



CARLTON & DEBORAH RANDALL SURVEY 2.001 ACRE TRACT

Commencing at a Monument Box (found) at the Southwest corner of the Northwest Quarter of Section 24, Duchouquet Township and in the centerline of Township Road 166 (Blackhoof Creek Road;

Thence S.89°31'49"E. along the South line of the Northwest Quarter of said Section 24 and along the centerline of Township Road 166, a distance of 1,329.29 feet to a Mag Nail (set) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence N.01°00'02"E. along the West line of the East ½ of the Northwest Quarter of said Section 24, a distance of 435.84 feet to a 5/8-inch iron pin (set), passing thru a 5/8-inch iron pin (set) for reference at 20.00 feet;

Thence S.89°31'49"E., parallel to the South line of the Northwest Quarter of Section 24 and the centerline of Township Road 166, a distance of 200.00 feet to a 5/8-inch iron pin (set);

Thence S.01°00'02"W. a distance of 435.84 feet to a Mag Nail (set), passing thru a 5/8inch iron pin (set) for reference at 415.84 feet;

Thence N89°31'49"W. along the Centerline of Township Road 166 and the South line of the Northwest Quarter of Section 24, a distance of 200.00 feet to the Mag Nail (set) which was the true PLACE OF BEGINNING.

Containing in all 2.001 Acre of which 0.115 Acre has been used for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises.
