## LAMMERS SURVEY 3.951 ACRES PT. PARCEL #M3602801100

SITUATE IN THE SOUTHEAST QUARTER OF SEC. 28, T 6S, R 5E, WASHINGTON TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF A 80 ACRE TRACT OF LAND OWNED BY BLAIR A. LAMMERS & BETH R. LAMMERS AS RECORDED IN OFFICIAL RECORD 592 PAGE 816 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at an one inch iron pin found in a Auglaize County Engineer's monument box found at the southwest corner of the southeast quarter of Section 28 and being in the centerline of Southland Road;

Thence, with the south line of the southeast quarter of Section 28 and the centerline of Southland Road, South 89°51'24" East, 236.63 feet to a Mag Nail set, said Mag Nail also marking the **`True Point of Beginning** of the tract herein described;

Thence, with a new division line, North 00°18'28" West, 718.58 feet to an iron pin set, passing for reference at 20.00 feet an iron pin set in the north right of way line of Southland Road;

Thence, with a new division line, South 89°51'24" East, 239.53 feet to an iron pin set;

Thence, with a new division line, South 00°18'28" East, 718.58 feet to a Mag Nail set in the south line of the southeast quarter of Section 28 and the centerline of Southland Road, passing for reference at 698.58 feet an iron pin set in the north right of way line of Southland Road;

Thence, with the south line of the southeast quarter of Section 28 and the centerline of Southland Road, North 89°51'24" West, 239.53 feet to the **True Point of Beginning**, containing 3.951 acres more of less with 0.110 acres lie within the right of way of Southland Road and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
