Commencing at an existing Mag Spike at the intersection of the centerlines of Wayne Street and Greenville Road; thence S 74°-59'-37" W on the centerline of Greenville Road, 529.27' to a set Mag Nail; thence S 01°-11'-59" W, 31.24' to a #5 Rebar set on the South line of Greenville Road and being at the POINT OF BEGINNING; thence the following courses:

- 1. N 74°-59'-37" E on the South line of Greenville Road, 231.11' to a set Mag Nail;
- 2. S 10°-44'-52" E, 44.04' to a set Mag Nail;
- 3. N 79°-15'-08" E, 10.63' to a set Mag Nail;
- 4. S 01°-12'-06" W, 748.09' to an existing #5 Rebar, passing an existing #5 Rebar at 743.61';
- 5. S 74°-08'-51" W, 147.70' to an existing #5 Rebar;
- 6. S 01°-15'-19" W, 219.43' to a #5 Rebar set on the South line of the North ½ of Section 10, passing an existing #5 Rebar at 169.54';
- 7. N 89°-07'-20" W on the South line of the North ½ of Section 10, 100.00' to a set #5 Rebar;
- 8. N 01°- 11'-59" E, 987.77' to the POINT OF BEGINNING.

- 1. Continue N 74°-59'-37" E on the South line of Greenville Road, 20.33' to a point;
- 2. S 01°-12'-06" W, 46.55' to a set Mag Nail;
- 3. S 79°-15'-08" W, 10.63' to a set Mag Nail;
- 4. N 10°-44'-52" W, 44.04' to the POINT OF BEGINNING.
