

SITUATE IN THE SOUTHEAST QUARTER OF SECTION 32 TOWN 5S RANGE 4E, NOBLE TOWNSHIP, AUGLAIZE COUNTY OHIO, PART OF LOT 52 OF WEST OAKS LAKES NO. 2 AS RECORDED PLAT CABINET C PAGE 229 IN THE CITY OF ST. MARYS AS OWNED BY MATTHEW I. SNAVELY & DEANA M. SNAVELY AS RECORDED IN OFFICIAL RECORD 721 PAGE 5591 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at a concrete monument found at the southeast corner of West Oaks Lakes No. 2 as recorded in Plat Cabinet C Page 229 and the southeast corner of Lot 53 of said subdivision also being in the south corporation line of the City of St. Marys;

Thence, with the south line of said West Oaks Lakes No. 2, aforesaid Lot 53 and the north line of a 50.000 acre tract of land owned by Maureen Liette, Trustee as recorded in Official Record 512 Page 1752 and the south corporation line of the City of St. Marys, North 89°14'50" West, 20.40 feet to an iron pin found, said iron pin also marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the south line of said West Oaks Lakes No. 2 and the north line of the aforesaid 50.000 acre tract and the south corporation line of the City of St. Marys, North 89°14'50" West, 36.19 feet to an iron pin set;

Thence, with a new division line, North 00°45'10" East, 29.78 feet to an iron pin set in the south line of said Lot 53;

Thence, with the south line of said Lot 53, South 49°47'53" East, 46.87 feet to the **True Point of Beginning**, containing 0.012 acre more of less and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in the County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
