## Parcel "A" LEGAL DESCRIPTION

Being a part of Parcel #I45-005-010-00 and being a part of the N  $\frac{1}{2}$  of the NE  $\frac{1}{2}$  of Section 5, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio (Prior Deed Referenced in O.R. 68, Pg. 514), more particularly described as follows:

Commencing at an existing Concrete Monument at the NW corner of Section 5; thence S 89°-40′-30″ E with the N line of Section 5, 2582.22′ to an existing Mag Spike at the intersection of said N line and the centerline of County Road 25-A; thence S 05°-04′-45″ E with said centerline, 657.97′ to an existing Mag Spike; thence S 89°-41′-06″ E, 531.70′ to a #5 Rebar set at the POINT OF BEGINNING, passing an existing #5 Rebar at 50.22′; thence the following courses:

- 1. N  $00^{\circ}$ -57'-31" W, 287.79' to an existing ½" Iron Pipe on the S right-of-way line of State Route 33;
- 2. N 86°-41′-32″ E with the S right-of-way line of State Route 33, 603.28′ to an existing ODOT Concrete Monument;
- 3. N 61°-37'-54" E with the S right-of-way line of State Route 33, 110.09' to a set #5 Rebar;
- 4. S 00°-18'-54" W, 378.68' to a set #5 Rebar;
- 5. N 89°-41'-06" W, 692.26' to the POINT OF BEGINNING.

The above described parcel contains 5.000 acres, more or less, subject to all legal highways and easements of record.

Commencing at an existing Concrete Monument at the NW corner of Section 5; thence S 89°-40′-30″ E with the N line of Section 5, 2582.22′ to an existing Mag Spike at the intersection of said N line and the centerline of County Road 25-A; thence S 05°-04′-45″ E with said centerline, 657.97′ to an existing Mag Spike; thence S 89°-41′-06″ E, 1223.96′ to a #5 Rebar set at the POINT OF BEGINNING, passing an existing #5 Rebar at 50.22′; thence the following courses:

- 1. N 00°-18'-54" E, 378.68' to a #5 Rebar set on the S right-of-way line of State Route 33;
- 2. N 61°-37'-54" E with the S right-of-way line of State Route 33, 345.08' to a set #5 Rebar;
- 3. N 76°-56'-40" E with the S right-of-way line of State Route 33, 467.22' to an existing ½" Iron Pipe;
- 4. S 01°-12'-58" W, 652.43' to an existing 6" Wood Post;
- 5. N 89°-41'-06" W, 747.03' to the POINT OF BEGINNING.
