



# HERBERT JOHNSON LOT SPLIT

Thence S.89°49'18"E. along the North line of the Southwest Quarter of said Section 9 and along the centerline of Township Road 186, a distance of 825.00 feet to a Mag Nail (set) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.89°49'18"E. along the above described line, a distance of 280.50 feet to a Mag Nail (set);





Thence continuing N.89°49'18"E. along the above described line, a distance of 280.50 feet to a Mag Nail (set);


