DOUGLAS & CONNIE LEFFEL SURVEY PT. PARCEAL #H2302600702 5.001 ACRES

SITUATE IN THE SOUTHEAST QUARTER OF SECTION 26, TOWN 5S, RANGE 4E NOBLE TOWNSHIP, AUGLAIZE COUNTY OHIO, PART OF THOSE LANDS OWNED BY CONNIE ANN AND DOUGLAS DEAN LEFFEL AS RECORDED IN OFFICIAL RECORD 641 PAGE 221 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at an Auglaize County Engineers Office Monument Box found at the southeast corner of the southeast quarter of Section 26 and being in the center of Vogel Rd.;

Thence, with the east line of the southeast quarter of Section 26, North 01°27'36" East, 606.49 feet to an iron pin set, said iron pin marking the **True Point of Beginning** of the tract herein described;

Thence, with a new division line, North 88°31'43" West, 1364.35 feet to a Mag Nail set in the centerline of State Route 66, Station 741+55.74, passing at 1307.97 feet an iron pin set in the east right of way line of State Route 66, Station 741+95.48, 40' Right;

Thence, with the centerline of State Route 66, North 46°16'53" East, 239.93 feet to a Mag Nail found, Station 743+95.67, at the southwest corner of a 5.032 acre tract of land owned by Derek D. Leffel & Luke L. Leffel ½ interest as recorded in Official Record 689 Page 1153;

Thence, with the south line of said 5.032 acre tract, South 88°31'43" East, 1195.23 feet to an iron pin with "Lock Two" cap found in the west line of the southwest quarter of Section 25 and the west line of a 51.99 acre tract of land owned by Gregory L. Leffel & Joan E. Leffel and Douglas Dean Leffel & Connie Ann Leffel as recorded in Official Record 613 Page 799, passing for reference at 60.90 feet an iron pin with "Lock Two" cap found;

Thence, with the west line of the southwest quarter of Section 25 and the west line of said 51.999 acre tract, South 01°27'36" West, 170.22 feet to the **True Point of Beginning**, containing 5.001 acres more or less of which 0.229 acres lie within the right of way of State Route 66 and being subject to all legal rights of ways easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). Stationing list hereon is per Ohio Department of Transportation right of way Plans AUG-66-11.88, Sheet 184 of 189. The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
