QUELLHORST SURVEY PT. PARCEL K2927100100 2.126 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 27 TOWN 6S RANGE 4E, ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY DEAN M. QUELLHORST & SUSUAN K. QUELLHORST AS RECORDED IN OFFICIAL RECORD 585 PAGE 583 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at monument box found at the northeast corner of the northeast quarter of Section 27;

Thence, with the east line of the northeast quarter of Section 27, South 00°57'02" West, 1331.44 feet to a 5/8 inch iron pin found at the southeast corner of a 37.150 acre tract of land owned by Ned J. Warner & Sherry A. Warner as recorded in Official Record 569 Page 2106, said iron pin marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the east line of the northeast quarter of Section 27, South 00°57'02" West, 220.00 feet to an iron pin set;

Thence, a new division line, North 89°07'42" West, 420.95 feet to an iron pin set, passing for reference at 25.00 feet an iron pin set in the west right of way line of State Route 66;

Thence, with a new division line, North 00°57'02" East, 220.00 feet to an iron pin set in the south line of said 37.150 acre Warner tract;

Thence, with the south line of said Warner tract, South 89°07'42" East, 420.95 feet to the **True Point of Beginning** passing for reference at 395.95 feet a 5/8 inch iron pin found, containing 2.126 acres more or less of which 0.126 acres lie within the right of way of State Route 66 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
