


SITUATE IN PART O.L. 38 OF THE NORTHEAST QUARTER OF SECTION 15 & THE NORTHWEST QUARTER OF SECTION 14, TOWN 7S, RANGE 4E GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, PART OF THOSE LANDS OWNED BY COMMUNITY IMPROVEMENT CORPORATION NEW BREMEN, OHIO AS RECORDED IN OFFICIAL RECORD 721 PAGE 307 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at an iron pin set at the northeast corner of Lot 395 of Koops Boesche & Koops South Addition as recorded in Plat Book 1 Page 44 and being in the south line of East Cherry Street, said iron pin also marking the **Point of Beginning** of the tract herein described;

Thence, with the south line of East Cherry Street, North 84°47'00" East, 284.15 feet to an iron pin set in the east line of a 1.740 acre tract of land owned by Crown Controls Corporation as recorded in Deed Volume 257 Page 206, passing for reference at 279.97 feet the east line of Section 15;

Thence, with the west line of said 1.740 acre tract and the west line of a 4.722 acre tract of land owned by Crown Equipment Corporation as recorded in Official Record 552 Page 1095, South 00°56'18" West, 268.68 feet to an iron pin with "Holt" cap found in the north line of a 0.386 acre tract of land owned by Crown Equipment Corporation as recorded in Official Record 552 Page 1095 and the south line of Out Lot 38;

Thence, with the south line of Out Lot 38 and the north line of said 0.386 acre tract, South 84°58'41" West, 256.49 feet to an iron pin with "Holt" cap found in the east line of Koops Boesche & Koops South Addition, passing for reference at 4.96 feet the east line of Section 15;

Thence, with the east line of Koops Boesche & Koops South Addition, North 04°58'11" West, 266.27 feet to the **Point of Beginning**, containing 1.655 acres more or less of which 0.028 acres lie in the the northwest quarter of Section 14 and 1.627 acres lie in the northeast quarter of Section 15 and being subject to all legal rights of ways easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
