SITUATE IN THE NORTHEAST QUARTER OF SECTION 15, TOWN 7S, RANGE 4E GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING PART OF THOSE LANDS OWNED BY CROWN EQUIPMENT CORPORATION AS RECORDED IN OFFICIAL RECORD 569 PAGE 1985 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at an iron pin set at the northeast corner of Out Lot 12 of Vogelsang Town as recorded in Plat Book 1 Page 124 and being in the south line of Plum Street, said iron pin also marking the **Point of Beginning** of the tract herein described;

Thence, with the south line of Plum Street, South 89°11'37" East, 22.37 feet to an iron pin set in the west line of the Miami and Erie Canal;

Thence, with the west line of the Miami and Erie Canal, South 09°51'13" West, 49.34 feet to an iron pin set;

Thence, with the west line of the Miami and Erie Canal, South 10°09'43" West, 100.33 feet to an iron pin set in the north line of Out Lot 13 owned by Crown Equipment Corporation as recorded in Official Record 569 Page 1985;

Thence, with the north line of Out Lot 13, North 89°11'37" West, 179.76 feet to an iron pin set in the east line of a tract of land owned by Gray Fox, LTD as recorded in Official Record 284 Page 442;

Thence, with the east line of said Gray Fox, LTD lands and the center line of an open ditch, the following two courses:

1. North 12°15'26" East, 62.61 feet to an iron pin set;


Thence, with the south line of said 0.07 acre tract, South 89°11'37" East, 142.68 feet to an iron pin set in the west line of Out Lot 6;

SITUATE IN THE NORTHEAST QUARTER OF SECTION 15, TOWN 7S, RANGE 4E GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING PART OF THOSE LANDS OWNED BY CROWN EQUIPMENT CORPORATION AS RECORDED IN OFFICIAL RECORD 569 PAGE 1985 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at a 5/8 inch iron pin found at the southwest corner of Out Lot 14 and the southwest corner of a tract of land owned by Antonio Siano as recorded in Official Record 718 Page 1151;

Thence, with the north line of Out Lot 15 and the south line of said Siano tract, South 89°11'37" East, 122.00 feet to an iron pin set at the southeast corner of said Siano tract, said iron pin also marking the **True Point of Beginning** of the tract herein described;

Thence, with the east line of said Siano tract and the east line of tracts owned by Gary G. & Kristine A. Vondenhuevel as recorded in Official Record 689 Page 2099, Erica M. Niekamp as recorded in Official Record 724 Page 2396, Elizaneth M. Eiting as recorded in Official Record 568 Page 67 and Zachary J. Homan & Renee L. Homan as recorded in Official Record 718 Page 5877, North 00°51'56" East, 322.54 feet to an iron pin set in the south line of Out Lot 12 and the south line of a tract of land owned by Gray Fox, LTD as recorded in Official Record 284 Page 442;

Thence, with the south line of Out Lot 12, and said Gray Fox, LTD tract and that portion of Out Lot 12 owned by Crown Equipment Corporation as recorded in Official Record 569 Page 1985, South 89°11'37" East,191.55 feet to an iron pin set in the west line of the Miami and Erie Canal;

Thence, with the west line of the Miami and Erie Canal, South 10°09'43" West, 326.89 feet to an iron pin found with "Lock Two" cap found in the north line of Out Lot 15 and a 2.69 acre tract of land owned by Crown Equipment Corporation as recorded in Official Record 549 Page 1942;

Thence, with the north line of Out Lot 15 and the north line of said 2.69 acre tract, North 89°11'37" West, 138.74 feet to the **True Point of Beginning**, containing 1.223 acres more or less and being subject to all legal rights of ways easements, agreements and restrictions of record.
