



Description for Wapak Storage, LLC. 2.360 Acres

Being all of Lot 21 thru Lot 26 of Ashland Allotment as recorded in Plat Book Volume 2 Page 64, also being part of Lot 20 of Ashland Allotment as recorded in Plat Book Volume 2 Page 64, also being all of Lot 50 thru Lot 56 of Ardmore Addition as recorded in Plat Book Volume 2 Page 78, also being part of Lot 57 thru Lot 59 of Ardmore Addition as recorded in Plat Book Volume 2 Page 78, also being all of a 12' vacated alley located between Lot 52 and Lot 53 of Ardmore Addition as recorded in Plat Book Volume 2 Page 78, also being part of a 12' vacated alley that lies south of Lot 20 thru Lot 26 of Ashland Allotment and north of Lot 50 thru 59 of Ardmore Addition, located in the Southwest Quarter of Section 32, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio, and described as follows:

Commencing at an Iron Pin Found marking the Southeast Corner of Lot 59, marking the TRUE POINT OF BEGINNING;

Thence North 89°48'01" West along the North right-of-way line of Wapa Street, a distance of four hundred eighty-seven and zero hundredths feet (487.00') to an Iron Pin Set;

Thence North 00°08'40" East along the East line of a tract as recorded in Official Records Volume 664 Page 1685, a distance of one hundred forty-one and zero hundredths feet (141.00") to an Iron Pin Set;

Thence South 89°47'54" East along the South line of a tract as recorded in Official Records Volume 685 Page 1732, a distance of one hundred twenty-seven and fifteen hundredth feet (127.15') to a point, referenced by an Iron Pipe Found North 74°18'12" East -0.61';

Thence North 00°05'45" East along the East line of a tract as recorded in Official Records Volume 685 Page 1732, a distance of one hundred thirty-three and sixty-nine hundredths feet (133.69') to an Iron Pin Set;

Thence South 89°54'15" East along the South right-of-way line of Ashland Avenue, a distance of two hundred sixty and twenty-seven hundredths feet (260.27') to an Iron Pin Found;

Thence South 00°27'33" West along the West line of a tract as recorded in Official Records Volume 701 Page 1761, a distance of one hundred thirty-four and twenty hundredths feet (134.20') to an Iron Pin Found;

Thence South 89°49'36" East along the South line of a tract as recorded in Official Records Volume 701 Page 1761, a distance of three and twenty hundredths feet (3.20') to an Iron Pin Found;



Thence South 00°27'33" West along the South line of a tract as recorded in Official Records Volume 701 Page 1761, a distance of six and eighty-six hundredths feet (6.86') to a point;

Thence South 89°17'40" East along the South line of a tract as recorded in Official Records Volume 701 Page 1761, a distance of fifty-two and six hundredths feet (52.06') to a point;

Thence North 88°09'03" East along the South line of a tract as recorded in Official Records Volume 701 Page 1761, a distance of forty-five and twenty-four hundredths feet (45.24') to an Iron Pin Found;

Thence South 00°08'40" West along the West line of a tract as recorded in Official Records Volume 720 Page 5820, a distance of one hundred thirty-five and twenty-six hundredths feet (135.26') to the TRUE POINT OF BEGINNING, containing 2.360 acres of land more or less.

Said tract being subject to all highways and any other easements or restrictions of record.
