BEING PART OF E1400600201, A 48.553-ACRE TRACT OF LAND OWNED BY KENNETH H. OSTERLOH AS CONVEYED IN OFFICIAL RECORD 686, PAGE 344 OF THE AUGLAIZE COUNTY DEED RECORDS, SITUATE IN THE NORTHWEST QUARTER OF SECTION 6, TOWN 8 SOUTH, RANGE 4 EAST, JACKSON TOWNSHIP, AUGLAIZE COUNTY, OHIO AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

COMMENCING FOR REFERENCE AT A MONUMENT BOX FOUND AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION 6 AND BEING IN THE CENTERLINE OF OSTERLOH ROAD (40' R/W);

THENCE, NORTH 88°46′52″ WEST, 730.48 FEET, ALONG THE NORTH LINE OF SECTION 6 AND THE CENTERLINE OF OSTERLOH ROAD TO A RAILROAD SPIKE FOUND 8″ DEEP AT THE NORTHWEST CORNER OF A TRACT OF LAND OWNED BY KARD WELDING INC. AS CONVEYED IN OFFICIAL RECORD 87, PAGE 843 AND BEING THE PRINCIPAL PLACE OF BEGINNING OF THE TRACT HEREIN CONVEYED;

THENCE, SOUTH 02°04'48" WEST, 673.98 FEET, ALONG THE WEST LINE OF SAID KARD WELDING TRACT TO AN IRON PIN WITH CAP SET, PASSING FOR REFERENCE AN IRON PIN WITH CAP SET AT 20.00 FEET;

THENCE, NORTH 88°46'52" WEST, 225.00 FEET, TO AN IRON PIN WITH CAP SET;

THENCE, NORTH 02°04'48" EAST, 673.98 FEET, TO A MAG NAIL SET ON THE NORTH LINE OF SECTION 6 AND THE CENTERLINE OF OSTERLOH ROAD, PASSING FOR REFERENCE AN IRON PIN WITH CAP SET AT 653.98 FEET;


