MARYS, OHIO AS CONVEYED IN OFFICIAL RECORD 708, PAGE 3453 OF THE AUGLAIZE COUNTY DEED RECORDS, SITUATE IN THE NORTHWEST 1/4 OF SECTION 3, TOWN 6 SOUTH, RANGE 4 EAST, CITY OF ST. MARYS, AUGLAIZE COUNTY, OHIO AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN FOUND AT THE NORTHEAST CORNER OF SAID LOT 14 AND BEING AT THE NORTHWEST CORNER OF PART OUTLOT 15 OWNED BY SHANNON RION AS CONVEYED IN OFFICIAL RECORD 657, PAGE 285 AND BEING ON THE SOUTH LINE OF LOT 7 OF CANAL VIEW ESTATES, PHASE 1 AS SHOWN ON PLAT CABINET D, PAGE 143;

THENCE, SOUTH 00°47'55" WEST, 119.07 FEET, ALONG THE EAST LINE OF SAID LOT 14 AND THE WEST LINE OF SAID RION TRACT TO AN IRON PIN FOUND ON THE NORTH RIGHT-OF-WAY LINE OF HILLCREST DRIVE;

THENCE, NORTH 8912'05" WEST, 8.00 FEET, ALONG THE NORTH RIGHT-OF-WAY LINE OF HILLCREST DRIVE TO AN IRON PIN WITH CAP SET;

THENCE, NORTH 00°47'55" EAST, 119.08 FEET, TO AN IRON PIN WITH CAP SET ON THE NORTH LINE OF SAID LOT 14 AND BEING ON THE SOUTH LINE OF SAID LOT 7;


THENCE, SOUTH 89°07'47" EAST, 8.00 FEET, ALONG THE NORTH LINE OF SAID LOT 14 AND THE SOUTH LINE OF SAID LOT 7 TO THE PLACE OF BEGINNING.


