SITUATE IN THE SOUTHEAST QUARTER OF SECTION 21 TOWN 6S RANGE 5E, WASHINGTON TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING PART OF A TRACT OF LAND OWNED BY BRUCE AND MARGARET A. BAMBAUER AS RECORDED IN OFFICIAL RECORD 725 PAGE 4805 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at a brass plug in a monument box found at the northeast corner of the southeast quarter of Section 21 and being in the centerline of Bay Road, said monument box also marking the Point of Beginning of the tract herein described:

Thence, with the east line of the southeast quarter of Section 21 and the centerline of Bay Road, South 01°26'59" West, 50.01 feet, to a Mag Nail set;

Thence, with new division lines the following 4 courses;

- 1. North 89°43'10" West, 1251.72 feet to an iron pin set, passing for reference at 20.00 feet an iron pin set in the west right of way line of Bay Road;
- South 01°26'43" West, 449.99 feet to an iron pin set;
- North 89°43'10" West, 500.00 feet to an iron pin set;
- North 01°26'43" East, 500.00 feet to an iron pin set in the south line of a 74.99 acre tract of land owned by Douglas W. Bambauer (Trustee) and Sandra L. Bambauer (Trustee) as recorded in Official Record 702, Page 2297

Rodeheffer as recorded in Official Record 556, Page 382, South 89°43'10" East 1751.72 feet to Point of Beginning, passing for reference at 418.74 feet to an iron pin with "Lock Two" cap found, 1085.23 feet to iron pin with "Lock Two" cap and at 1731.72 feet to the west right of way line of Bay Road, containing 7.175 acres more or less and having 0.023 acres lie within the right of way line of Bay Road and being subject to all legal rights of way, easements, agreements and restrictions of record.

Commensing at a brass plug in a monument box found at the northeast corner of the southeast quarter of Section 21;

Thence, with the east line of the southeast quarter of Section 21 and the centerline of Bay Road, South 01°26'59" West, 1147.71 feet, to a Mag Nail found;

Thence, with the north line of a 88.060 acre tract of land owned by Anita Lukac Etal. as recorded in Official Record 677, Page 1057, North 89°51'32" West, 1479.83 feet to a iron pin with "Lock Two" cap found, passing for reference at 20.00 feet an iron pin with "Lock Two" cap found in the west right of way line of Bay Road;
