



NOTE: THE EAST LINE OF THE SOUTHWEST QUARTER OF THE NORTH WEST QUARTER OF FRACTIONAL SEC. 30 IS THE WEST LINE OF THE SUBJECT PARCEL. IT WAS ALSO SUPPOSED TO BE THE EAST LINE OF THE 1.12 ACRE ROBERTS TRACT. THE 1.12 ACRE TRACT WAS CREATED BY SURVEY L-134. THIS SURVEY APPEARS TO HAVE USED POST LOCATED AT THE SOUTH \$ NORTH ENDS OF THE SUBJECT PARCEL TO CREATE THIS LINE. AS EVIDENCED BY THIS SURVEY AND SURVEY M-546 THESE POST WERE EAST OF THE LINE CREATING AN OVERLAP BETWEEN THE 1.12 ACRE TRACT AND THE SUBJECT PARCEL AS SHOWN. BEFORE TRYING TO OCCUPY THESE LANDS LEGAL ADVICE IS ADVISED AS THERE MAY HAVE BEEN LEGAL RIGHTS CREATED DUE TO THE 1.12 ACRE TRACT HAVING BEEN IN EXISTENCE FOR OVER 28 YEARS.

SITUATE IN THE NORTHWEST AND THE NORTHEAST QUARTER OF SECTION 30 TOWN 4S RANGE 5E, LOGAN TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING PART OF A TRACT OF LAND OWNED BY DEBRA D. McMICHAEL AS RECORDED IN OFFICIAL RECORD 717 PAGE 2168 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at a monument box found at the southeast corner of the northwest quarter of Fractional Section 30 and then generally with the centerline of a unnamed ditch, said monument box marking the **Point of Beginning** of the tract herein described;

Thence, with the east line of the northwest quarter of said fractional Section 30, the general centerline of a unnamed ditch and a new division line, North 00°43'30" East, 1097.59 feet, passing for reference at 25.00 feet the north right of way line of Kossuth Loop Road;

Thence, continuing with the general centerline of a unnamed ditch and new division lines the following 8 courses;
