

LEGAL DESCRIPTION

Being a part of Parcel #K31-063-048-00 and being a part of the N $\frac{1}{2}$ of the NW $\frac{1}{2}$ of Section 19, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio (Prior Deed Referenced in O.R. 717, Pg. 2388), more particularly described as follows:

Commencing at an existing #5 Rebar at the SW corner of the N % of the NW % of Section 19; thence S 88°-57'-22" E with the S line of the N % of the NW % of Section 19 (centerline of Koehn Road), 1320.05' to an existing Mag Nail; thence N 01°-22'-51" E, 300.00' to an existing #5 Rebar at the POINT OF BEGINNING; thence the following courses:

- 1. Continuing N 01°-22'-51" E, 100.00' to a set #5 Rebar;
- 2. \$88°-57'-22" E, 175.00' to a set #5 Rebar;
- 3. S 01°-22'-51" W, 100.00' to an existing #5 Rebar;
- 4. N 88°-57'-22" W, 175.00' to the POINT OF BEGINNING.

The above-described parcel contains 0.402 acres, more or less, subject to all legal highways and easements of record.

Being a part of Parcel #K31-063-048-00 and being a part of the N½ of the NW¼ of Section 19, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio (Prior Deed Referenced in O.R. 717, Pg. 2388), more particularly described as follows:

Commencing at an existing #5 Rebar at the SW corner of the N½ of the NW¼ of Section 19; thence S 88°-57'-22" E with the S line of the N½ of the NW¼ of Section 19 (centerline of Koehn Road), 1495.05' to an existing Mag Nail; thence the following courses:

- 1. N 01°-22'-51" E, 400.00' to a set #5 Rebar;
- 2. S 88°-57'-22" E, 30.00' to a point;
- 3. S 01° -22′-51″ W, 400.00′ to a point on the S line of the N ½ of the NW ¼ of Section 19 (centerline of Koehn Road);
- 4. N 88°-57'-22" W with said fractional section line, 30.00' to the POINT OF BEGINNING.

The above description contains 0.275 acres, more or less, and has the sole purpose of creating an ingress/egress easement and is not intended for the transfer of ownership of real estate.
