Thence S.01°10'51"W. along the West line of the Southeast Quarter of said Section 34, a distance of 347.87 feet to a 5/8-inch iron pin (found);

Thence N.81°22'57"E. a distance of 676.35 feet to a 5/8-inch iron pin (set) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence N.00°46'54"W. a distance of 288.40 feet to a 5/8-inch iron pin (set), in the South right-of-way line of County Road 33-A;

Thence N.81°13'53"E. along the South right-of-way line of County Road 33-A, a distance of 18.00 feet to a 5/8-inch iron pin found;

Thence S.01°09'28"W. along the existing property line between Darren M. Jurosic and Jacob Lochard a distance of 289.95 feet to an iron pipe (found);

Thence S.81°22'57"W. along the South line of the Darren M. Jurosic's 0.981 Acre property, a distance of 8.09 feet to a 5/8-inch iron pin (set), which was the true PLACE OF BEGINNING.

Thence S.01°10'51"W. along the West line of the Southeast Quarter of said Section 34, a distance of 347.87 feet to a 5/8-inch iron pin (found);

Thence N.81°22'57"E. a distance of 534.44 feet to a 10-inch dia. wood post (found) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence N.01°16'14"E. a distance of 289.66 feet to a point in the South right-of-way line of County Road 33-A;

Thence N.81°13'53"E. along the South right-of-way line of County Road 33-A, a distance of 131.49 feet to a 5/8-inch iron pin set;

Thence S.00°46'54"E. along the newly established property line between Darren M. Jurosic and Jacob Lochard a distance of 288.40 feet to a 5/8-inch iron pin (set);
