


SITUATE IN THE NORTHWEST QUARTER OF SECTION 19 TOWN 6S RANGE 4E, ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING A PART OF A TRACT OF LAND OWNED BY GARY LIETTE FARMS INC. AS RECORDED IN OFFICIAL RECORD 512 PAGE 1758 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at a one inch iron pin found in a monument box located at the northeast corner of the northwest quarter of Section 19 and being in the centerline of Schroeder Road;

Thence, with the east line of the northwest quarter of Section 19 and the centerline of Schroeder Road, South 01°09'27" West, 345.58 feet to a railroad spike found at the southeast corner of a 0.076 acre tract of land, said tract is owned by the Auglaize County Board of Commissioners as recorded in Official Record 106 Page 300, said railroad spike also marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the east line of the northwest quarter of Section 19 and the centerline of Schroeder Road, South 01°09'27" West, 345.60 feet to a Mag Nail set;

Thence, with a new division line, North 88°58'06" West, 316.87 feet to an iron pin set, passing for reference at 45.00 feet an iron pin set in the west right of way line of Schroeder Road;

Thence, with a new division line, North 01°09'27" East, 399.60 feet to an iron pin set in the south line of a 11.877 acre tract of land owned by Matthew D. Slife as recorded in Official Record 712 Page 4664;

Thence, with the south line of said 11.877 acre tract of land, South 88°58'06" East, 254.87 feet to a 5/8 inch iron pin found at the northwest corner of the aforesaid 0.076 acre Auglaize County Board of Commissioners tract;

Thence, with the west line of said 0.076 acre tract, South 01°09'27" West, 54.00 feet to an iron pin set;
