



## Annexation to the Village of New Bremen 21.691 Acres

Being all of an 11.257 acres tract as recorded in Official Records Volume 450 Page 421; also being part of a 15.654 acres tract as recorded in Official Records Volume 68 Page 567; also being part of a 12.582 acres tract as recorded in Official Records Volume 452 Page 589, located in the Northwest Quarter and the Southwest Quarter of Section 14, Town 7 South, Range 4 East, German Township, Auglaize County, Ohio, and described as follows:

Commencing at a Concrete Monument Found marking the Center of Section 14;

Thence South 01°21'20" West (Basis of Bearings) along the East line of the Southwest Quarter of Section 14, a distance of eight hundred four and eighty-six hundredths feet (804.86') to a Concrete Monument Found;

Thence North 89°55'04" West along the North line of a tract as recorded in Official Records Volume 452 Page 589, a distance of eight hundred seventeen and fifty-seven hundredths feet (817.57') to an Iron Pin Set, marking the TRUE POINT OF BEGINNING;

Thence continuing North 89°55'04" West along the North line of a tract as recorded in Official Records Volume 452 Page 589, a distance of two hundred seventeen and twenty-five hundredths feet (217.25') to an Iron Pin Set;

Thence North 89°47'12" West along the North line of a tract as recorded in Official Records Volume 452 Page 593, a distance of seven hundred eighty-nine and forty-seven hundredths feet (789.47') to a Concrete Monument Found;

Thence North 01°21'33" East along the East line of Lot #1 and Lot #2 of Dicke Subdivision and the existing corporation line of New Bremen as recorded in Plat Cabinet A Page 30, a distance of nine hundred eleven and thirty-eight hundredths feet (911.38') to a Concrete Monument Found;

Thence North 89°49'32" West along the North line of Lot #1 of Dicke Subdivision and the existing corporation line of New Bremen, a distance of one hundred sixty-six and thirty-three hundredths feet (166.33') to a point;

Thence North 01°03'46" East along the existing corporation line of New Bremen, a distance of twenty-one and ninety-six hundredths feet (21.96') to a point;

Thence North 89°40'11" East along the South line of a tract as recorded in Official Records Volume 441 Page 390, a distance of five hundred forty-three and seventy-six hundredths feet (543.76') to an Iron Pin Found;



Thence South 89°49'49" East along the South line of a tract as recorded in Official Records Volume 552 Page 1088, a distance of six hundred twenty-three and forty-nine hundredths feet (623.49') to an Iron Pin Set;

Thence South 00°59'27" West a distance of nine hundred thirty-eight and twenty-eight hundredths feet (938.28') to the **TRUE POINT OF BEGINNING**, containing **21.691 acres** of land more or less. Of which 2.925 acres is in the Northwest Quarter of Section 14 and 18.766 acres is in the Southwest Quarter of Section 14.

Said tract being subject to all highways and any other easements or restrictions of record.
