## NAGEL SURVEY DESCRIPTION

Being a part of Parcel Number M3602902301 (Official Record 528, page 1994), situated in Washington Township, Auglaize County, Ohio, in the east half of the southwest quarter of Section 29, Township 6 South, Range 5 East. Being more particularly described as follows:

Commencing for reference at an iron bar in a monument box found at the South Quarter Post of said Section 29 -

Thence, North  $01^{\circ}08'33''$  East, along the east line of the southwest quarter of said Section 29, a distance of 339.78 feet to a  $\frac{5}{10}$  inch iron bar found -

Thence, North 45°50'33" West, a distance of 167.45 feet to a 1/8 inch iron bar found -

Thence, North 11°26'33" West, a distance of 77.89 feet to a 1/8 inch iron bar found -

Thence, North 06°45'33" West, a distance of 23.70 feet to a ½ inch iron bar set. Said point being the place of beginning for the parcel of land to be conveyed by this instrument -

Thence, continuing, North 06°45'33" West, a distance of 61.60 feet to a 1/8 inch iron bar found -

Thence, North 01°03'50" East, a distance of 176.75 feet to a 1/8 inch iron bar found -

Thence, North 13°53'03" East, a distance of 63.87 feet to a 1/8 inch iron bar found -

Thence, North 89°32'16" West, a distance of 318.21 feet to a 1/8 inch iron bar found -

Thence, South 01°08'33" West, a distance of 300.00 feet to a 1/8 inch iron bar set -

Thence, South 89°32'16" East, a distance of 312.83 feet to the place of beginning.

Containing 2.111 acres of land more or less.

Subject to all easements and right-of-way of record.
