SITUATE IN THE NORTHEAST QUARTER OF SECTION 13, TOWN 5S, RANGE 5E, MOULTON TOWNSHIP AUGLAIZE COUNTY OHIO, AND BEING PART OF A TRACT OF LAND OWNED BY RICKEY J. PLACE & DIANE M. PLACE AS RECORDED IN OFFICIAL RECORD 600 PAGE 217 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Commencing at a P.K. Nail found at the northwest corner of the northeast quarter of Section 13, said P.K. Nail being in the centerline of State Route 197 and being at the northeast corner of a 39.769 acre tract of land owned by John E. Miller as recorded in Official Record 659 Page 2096, said P.K. Nail marking the **Point of Beginning** of the tract herein described;

Thence, with the north line of the northeast quarter of Section 13 and the centerline of State Route 197, South 88°58'53" East, 1442.16 feet to a Mag Nail found in the intersection of the centerlines of State Route 197 and State Route 198:

Thence, with the centerline of State Route 198, South 24°51'40" East, 1228.15 feet to a Mag Nail set at the northeast corner of a 0.92 acre tract of land owned by Brett W. Place & Virginia M. Place as recorded in Official Record 729 Page 1768;

Thence, with the lines of said 0.92 acre tract the following 3 courses:

- 1. South 89°34'52" West, 152.98 feet to an iron pin with Jauert cap found, passing for reference at 32.95 feet an iron pin set;
- 2. South 00°12'32" West, 199.19 feet to a 5/8 inch iron pin found;
- 3. South 89°09'48" East, 248.22 feet to a Mag Nail set in the centerline of State Route 198, passing for reference at 215.61 feet the west right of way line of State Route 198 and at 214.93 feet an iron pin with Jauert cap found;

Thence, with the centerline of State Route 198, South 24°51'40" East, 23.11 feet to a Mag Nail set

Thence, with the centerline of State Route 198, South 24°23'57" East, 708.88 feet to a Mag Nail set;

Thence, with a new division lines the following 3 courses:

- 1. North 89°09'55" West, 1961.82 feet to an iron pin set, passing for reference at 33.16 feet an iron pin set in the west right of way line of State Route 198;
- 2. North 00°47'59" West, 647.23 feet;
- 3. North 89°06'48" West, 404.27 feet to an iron pin set in the east line of the aforesaid 39.769 acre Miller tract;

Thence, with the east line of said 39.769 acre tract, North 00°50'36" East, 1328.58 feet to the **Point of Beginning**, passing for reference at 1298.58 feet an iron pin set in the south right of way line of State Route 197, containing 79.693 acres more or less of which 2.325 acres lie in the right of way lines of State Route 197 & 198 and being subject to all legal rights of way, easements, agreements and restrictions of record;



Beginning at a wood post found at the southwest corner of the northeast quarter of Section 13 and the northwest corner of a 39.129 tract of land owned by Steven J. Koenig & Sandra Koenig as recorded in Official Record 720 Page 4436, said post also marking the **Point of Beginning** of the tract herein described;

Thence, with the east line of a 39.769 acre tract of land owned by John E. Miller as recorded in Official Record 659 Page 2096, North 00°50'36" East, 1328.58 feet to an iron pin set;

Thence, with a new division line, South 89°06'48" East, 404.27 feet;

Thence, with a new division line, South 00°47'59" East, 647.23 feet to an iron pin set;

Thence, with a new division line, South 89°09'55" East, 1961.82 feet to a Mag Nail set in the centerline of State Route 198, passing for reference at 1928.66 feet an iron pin set in the west right of way line of State Route 198;
