




## LEGAL DESCRIPTION

Being Parcel #B07-002-030-00, with prior deed referenced in O.R. 632, Page 768, being part of Inlot #98 recorded in P.B. 18, Page 20 and part of Lot #7 of Fraction 25 of Section 29, located in the SW 1/4 of Section 29, T5S, R6E, City of Wapakoneta, Duchouquet Township, Auglaize County, Ohio, more particularly described as follows:

BEGINNING at a Mag Nail set at the Southwest corner of the Roode Family Properties, LLC property (O.R. 730, Page 5695); thence the following courses:

- 1. N 86°-45'-40" W on the North line of West Auglaize Street, 25.06' to point, said point referenced by a set Mag Nail being S 03°-10'-46" W, 3.00' from said point;
- 2. N 03°-10'-46" E, 156.57' to a set Mag Nail;
- 3. S 86°-42'-58" E, 25.06' to an existing Mag Nail;
- 4. S 03°-10'-46" W, 156.55' to the POINT OF BEGINNING.
