


SITUATE IN THE SOUTHWEST QUARTERS OF SECTION 22, TOWN 6S, RANGE 7E CLAY TOWNSHIP, AUGLAIZE COUNTY OHIO AND BEING PART OF THOSE LANDS OWNED BY STANELY J. BROWN & DEBBIE REINHART BROWN AS RECORDED IN OFFICIAL RECORD 727 PAGE 5126 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning at a Mag Nail found over a railroad spike found at the southeast corner of the southwest quarter of Section 22 and being in the centerline of State Route 720, said Mag Nail also marking the **Point of Beginning** of the tract herein described;

Thence, with the south line of the southwest quarter of Section 22 and the centerline of State Route 720, North 88°59'16" West, 19.83 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with continuing with the south line of the southwest quarter of Section 22 and the centerline of State Route 720, North 88°59'16" West, 189.65 feet to a Mag Nail found at the southeast corner of a 2.398 acre tract of land owned by Jared W. Selover & Elizabeth L. Ruppert as recorded in Official Record 599 Page 1598;

Thence, with the east line of said 2.398 acre tract, North 00°31'11" East, 302.52 feet to a 5/8 inch iron pin (disturbed) found;

Thence, with a new division line, South 89°00'01" East, 191.22 feet to an iron pin set;

Thence, with a new division line, South 00°49'03" West, 302.55 feet to the **True Point of Beginning**, containing 1.323 acres more or less of which 0.109 acres lie in the right of way of State Route 720 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
