Thence S.01°05'27"W. along the West line of the Northeast Quarter of said Section 35, a distance of 1,096.33 feet to a 5/8-inch dia. iron pin (found);

Thence S.89°32'36"E., along the North line of Parcel No. E15-353-004-00, a distance of 229.45 feet to a 5/8-inch dia. iron pin (found), which is the PLACE OF BEGINNING for the tract of land herein described;
