Commencing for reference at a one inch iron pin found in a monument box at the northeast corner of the northeast quarter of Section 23 and being in the intersection of the centerline of Fryburg East & Winemiller Roads;

Thence, with the north line of the northeast quarter of Section 23 and the centeline of Fryburg East Road, North 89°52'10" West, 1085.92 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with a new division line, South 00°52'18" West, 421.00 feet to an iron pin set, passing for reference at 25.00 feet an iron pin set in the south right of way line of Fryburg East Road;

Thence, with a new division line, North 89°52′10" West, 207.00 feet to the east line of a 76.84 acre tract of land owned by Bruce and Tracy L. Schuman as recorded in Official Record 713 Page 2146;
