IMWALLE RETRACEMENT SURVEY PARCEL #H2303300200 81.632 ACRES

SITUATE IN THE NORTHWEST QUARTERS OF SECTION 33, TOWN 5S, RANGE 4E, NOBLE TOWNSHIP, AUGLAIZE COUNTY OHIO, ALL OF THOSE LANDS OWNED BY TORI J. IMWALLE AS RECORDED IN OFFICIAL RECORD 730 PAGE 3632 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at a iron pin set at the northeast corner of the northwest quarter of said Section 33, said iron pin marking the **Point of Beginning** of the tract herein described;

Thence, with the north line of the northeast quarter of Section 33 and the south line of a 88.394 acre tract of land owned by KSD Farms Inc. as recorded in Official Record 681, Page 634, South 88°52'06" East, 381.99 feet to a Mag Nail set in the centerline of State Route 116, passing for reference at 349.91 feet an iron pin set in the west right of way line of State Route 116, witnessing at North 19°35'49" West, 2.39 feet a concrete right of way monument found;

Thence, with the centerline of State Route 116, South 19°35'49" East, 23.52 feet to a Mag Nail set, passing for reference at 3.86 feet an monumnet box with iron pin found;

Thence, with the north line of a 45.568 acre tract owned by Rohrbach Family Farms, LLC as recorded in Official Record 724, Page 1381, North 88°52'06" West, 390.33 feet to an iron pin set, passing for reference at 32.08 feet an iron pin set in the west right of way line of State Route 116;

Thence, with the west line of said 45.568 acre tract, South 01°10'33" West, 2648.51 feet to a steel fence post found at the southest corner of the northwest quarter of said Section 33;

Thence, with the south line of the northwest quarter of said Section 33, the north line of a 9.981 acre tract of land owned by Timothy G. and Susan K. Becher as recorded in Official Record 729, Page 950 and the north line of a 32.199 acre tract owned by Timothy G. Becher as recorded in Official Record 717, Page 2541, North 89°01'15" West, 1328.57 feet to an iron pin found;

Thence with the east line of said 32.199 acre tract and the east line of a 55.743 acre tract, North 01°13'19" East, 2674.05 feet to an iron pin set in the south line of said 88.394 acre KSD Farms Inc tract;

Thence, with the north line of the northwest quarter of Section 33, and the south line of said 88.39 acre tract, South 88°52'06" East, 1326.40 feet to the **Point of Beginning**, containing 81.632 acres more or less of which 0.016 acres lie within the right of way line of State Route 116 and being subject to all legal rights of ways easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
