


State Plane - North Coordinate System NAD83 (2011).

## **LEGAL DESCRIPTION**


Being a part of Parcel #B05-019-005-05 and being a part of the SW ¼ of Section 19, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio (Prior Deed Referenced in O.R. 609, Pg. 119), more particularly described as follows:

Commencing at an existing Monument Box at the NW corner of the SW ¼ of Section 19; thence S 89°-43′-52″ E with the N line of the SW ¼ of Section 19 (centerline of Infirmary Road), 557.26′ to a point; thence S 00°-44′-32″ W, 630.24′ to an existing #5 Rebar at the POINT OF BEGINNING, passing an existing Railroad Spike at 1.72′; thence the following courses:

- 1. S 89°-40'-44" E, 143.88' to an existing #5 Rebar;
- 2. S 00°-45′-10" W, 100.00' to a set #5 Rebar;
- 3. N 89°-40'-49" W, 143.47' to a set #5 Rebar;
- 4. N 00°-31′-08" E, 100.00' to the POINT OF BEGINNING.

The above-described parcel contains 0.330 acres, more or less, subject to all legal highways and easements of record.

- 1. S 89°-40'-44" E, 52.10' to an existing #5 Rebar;
- 2. S 00°-31'-08" W, 100.00' to a set #5 Rebar;
- 3. N 89°-40'-49" W, 52.10' to a set #5 Rebar;
- 4. N 00°-31′-08" E, 100.00′ to the POINT OF BEGINNING.

The above description contains 0.120 acres, more or less, and has the sole purpose of creating an ingress/egress easement and is not intended for the transfer of ownership of real estate.
