Beginning at a 5/8 inch iron pin found at the Southeast corner of Out Lot 18 in the village of New Knoxville;

Thence, with the south line of Outlot 18, North 89°26'08" West, 396.20 feet to an iron pin set at the northwest corner of a 6.38 acre Part of Out Lot 17 owned by Hoge Lumber Company as recorded in Deed Volume 142 Page 413, said iron pin marking the **True Point of Beginning** of the tract herein described;

Thence, with the west line of said 6.38 acre Part of Out Lot 17, South 01°33'14" West, 433.75 feet to an iron pin set in the north line of the southeast quarter of Section 30 and a 6.354 acre tract of land owned by Hoge Lumber Company as recorded in Deed Volume 254 Page 841;

Thence, with the north line of said 6.354 acre tract, North 89°26'08" West, 90.33 feet to an iron pin set;

Thence, with a new division line, North 00°33'52" East, 433.69 feet to an iron pin set in the south line of a Out Lot 18;

Thence, with the south line of Out Lot 18, South 89°26'08" East, 97.82 feet to the **Point of Beginning**, containing 0.937 acres more or less and being subject to all legal rights of way, easements, agreements and restrictions of record.
