


## J. HOGE (TRUSTEE) SURVEY PARCEL M3602901900 12.691 ACRES

SITUATE IN THE SOUTHWEST QUARTER OF SECTION 29, TOWN 6S, RANGE 5E WASHINGTON TOWNSHIP, AUGLAIZE COUNTY OHIO AND BEING ALL OF THOSE LANDS OWNED BY JOHN H. HOGE (TRUSTEE) AS RECORDED IN OFFICIAL RECORD 723 PAGE 4198 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at a P.K. Nail found at the southwest corner of the southwest quarter of Section 29 and being in the intersection of the centerlines of State Route 29 and Southland Road;

Thence, with the west line of the southwest quarter of Section 29 and the centerline of State Route 29, North 01°01'31" East, 1336.39 feet to a Mag Nail set at the northwest corner of a 40 acre tract of land owned by Craig A. Schrolucke & Kimberly Schrolucke-Smith (Trustees) as recorded in Official Record 720 Page 4573, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the west line of the southwest quarter of Section 29 and the centerline of State Route 29, North 01°01'31" East, 417.30 feet to a Mag Nail set at the southwest corner of a 7.6 acre tract of land owned by the Village of New Knoxville as recorded in Official Record 460 Page 2640;

Thence, with the south line of said 7.6 acre tract of land, South 89°33'48" East, 1324.22 feet to an iron pin set in the west line of a 12.655 acre tract of land owned by Douglas W. Bambauer (Trustee) & Sandra L. Bambauer (Trustee) Official Record 727 Pages 1420 & 1424, passing for reference at 50.00 feet an iron pin with Jauert cap found in the east right of way line of State Route 29;

Thence, with the west line of said 12.655 acre tract, South 01°07'20" West, 417.94 feet to an iron pin set in the north line of a foresaid 40 acre Schrolucke tract of land;

Thence, with the north line of said 40 acre tract, North 89°32'09" West, 1323.50 feet to the **True Point of Beginning**, passing for reference at 1273.50 feet an iron pin set in the east right of way line of State Route 29, containing 12.691 acres more or less of which 0.479 acres lie in the right of way of State Route 29 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
