

SITUATE IN THE NORTHEAST QUARTER OF SECION 31, T5S, R5E MOULTON TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF A 51.694 ACRE TRACT OF LAND OWNED BY PATRICK R. SEVERT AND VICTORIA L. SEVERT REVOCABLE LIVING FAMILY TRUST AS RECORDED IN OFFICIAL RECORD 438 PAGE 1832 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at a one inch iron pin found in a monument box at the northeast corner of the northeast quarter of Section 31 and being in the intersection of the centerlines of Vogel and Glynwood-New Knoxville Roads;

Thence, with the east line of the northeast quarter of Section 31 and the centerline of Glynwood-New Knoxville Road, South 01°52'54" West, 1761.19 feet to a Gin Spindle found, said Gin Spindle marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the east line of the northeast quarter of Section 31 and the centerline of Glynwood-New Knoxville Road, South 01°52'54" West, 89.27 feet to a Mag Nail set;

Thence, with a new division line, North 89°41'18" West, 270.82 feet to an iron pin set, passing for reference at 20.00 feet an iron pin set in the west right of way line of Glynwood-New Knoxville Road;

Thence, with a new division line, North 00°09'38" East, 89.24 feet to a 5/8 inch iron pin found at the southwest corner of a 0.151 acre tract of land owned by Jeff E. Sweigart & Kimberly A. Severt Sweigart as recorded in Official Record 605, Page 1699;

Thence, with the south line of said 0.151 acre tract and the south line of a 0.123 acre tract of land owned by Jeff E. Sweigart & Kimberly A. Severt Sweigart as recorded in Official Record 454 Page 96, South 89°41'18" East, 273.50 feet to the **True Point of Beginning**, passing for reference at 20.01 feet the west right of way line of Glynwood-New Knoxville Road, containing 0.558 acres more or less of which 0.041 acres lie in the right of way of Glynwood-NewKnoxville Road and being subject to all legal rights of way, easements, agreements and restrictions of record in.
