



SITUATE IN THE NORTHEAST QUARTER OF SECTION 18 TOWN 7S RANGE 4E, GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY DLH LAND AS RECORDED IN OFFICIAL RECORD 702 PAGE 4562 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at an Mag Nail found at the northwest corner of the northeast quarter of Section 18 and being in the intersection of State Route 274 and Wilker Road;

Thence, with the north line of the northeast quarter of Section 18 and the center line of State Route 274, South 89°05'19" East, 2121.86 feet to a Mag Nail set, said Mag Nail marking the True Point of Beginning of the tract herein described;

Thence, continuing with the north line of the northeast quarter of Section 18 and the center line of State Route 274, South 89°05'19" East, 361.82 feet to a Mag Nail set;

Thence, with a new division line, South 00°54'41" West, 150.36 feet to an iron pin set, passing for reference at 30.00 feet an iron pin set in the south right of way line of State Route 274;

Thence, with a new division line, North 89°05'19" West, 361.82 feet to an iron pin set;

Thence, with a new division line, North 00°54'41" East, 150.36 feet to the True Point of Beginning, passing for reference at 120.36 feet to an iron pin set in the south right of way line of State Route 274, containing 1.249 acres more or less of which 0.249 acre being in the right of way of State Route 274 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
