FREEWALT, CISCO & CRON SURVEY PT. PARCEL #H2301700500 5.001 ACRES

SITUATE IN THE SOUTHEAST QUARTER OF SECTION 17, T5S, R4E NOBLE TOWNSHIP, AUGLAIZE COUNTY, OHIO AND BEING A PART OF THOSE LANDS OWNED BY AMY FREEWALT, SCOTT CISCO, KIMBERLY CRON AND TY CISCO AS RECORDED IN OFFICIAL RECORD 733 PAGE 4701 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at a Monument Box found at the southwest corner of the southeast quarter of Section 17, said Monument Box also being in the center line of Noble Road;

Thence, with the south line of the southeast quarter of Section 17 and the center line of Noble Road, South 89°07'38" East, 765.38 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with a new division line, North 01°19'05" East, 385.97 feet to an iron pin set, passing for reference at 20.00 feet the north right of way line of Noble Road and at 25.00 feet an iron pin set;

Thence, with a new division line, South 89°07'38" East, 564.42 feet to an iron pin set in the west line of a 40.247 acre tract of land owned by Robert M. Post and Sharon L. Post as recorded in Official Record 649, Page 857;

Thence, with the west line of said 40.247 acre tract and the west line of a 3.000 acre tract of land owned by Gregory A. Snyder and Cynthia C. Snyder as recorded in Official Record 671, Page 875, South 01°19'05" West, 385.97 feet to the south line of the southeast quarter of Section 17 and the center line of Noble Road, witnessing at South 89°07'38" East, 0.15 feet a Mag Nail found, also witnessing at North 02°24'28"East, 24.90 feet an iron pin found, passing for reference at 20.00 feet the north right of way line of Noble Road;

Thence, with the south line of the southeast quarter of Section 17 and the center line of Noble Road, North 89°07'38" West 564.42 feet to the **True Point of Beginning** containing 5.001 acre more or less of which 0.259 acres lie within the right of way of Noble Road and being subject to all legal rights of ways easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
