 Second North Addition
 of Wapakonetta, Ohio
 North of the Dryden River
 Section Twenty Nine
 Township 14th Range 14th East
 Locality by Jeremiah Dyer, all lots
 are fifty feet in front of one hundred
 feet back. Except
 lots 14, 15, 16, 43, 44, 45, 46, 47, 48
 on North End, 50 feet. South End
 10 feet. N^o 14, North End 50. Running
 to a point on East Side of North End
 North End 52 feet, running to a point on
 East Line at fifty feet. Lot 16 North End 50 feet
 running to a point on East Line at 120 feet. N^o 46
 fifty feet on North End running to a point on East
 End, at 150 feet. Lot 44 on North Line 24 feet, running to
 a point on East Line, at 36 feet. Lot 45, North End 50 feet running to a point on East Line at 110 feet.
 Lot 30 on North End, 50 feet running to a point on East Line, at one hundred feet. All streets
 are 66 feet wide and all alleys are 16 feet wide running at right angles the proprietor donates all
 streets and alleys for Public Highways. Monuments placed for future survey and a stone, at South West
 corner of Lot No 20 & North East corner of Lot 32, and South West corner of 37. Attest M. L. Lethman S. C. C.
