



The North Addition to the Town of Brimm, Mercer County Ohio, is laid out on the North half of the South East quarter, of Section 5m (10) Township 36m (7) South of Range 2^o East East of first principal Meridian. This Addition contains Thirty In Lots. Three out Lots of a lot for a public Grave yard. There are five Streets in this Addition, Three of which Main, Herman & Franklin, bear N 75^o W. & the other two Pearl & Ash - run at right angles - thereto. Pearl, Ash & Main Streets, are each (70) Links wide. Franklin & Herman, are each twenty five (25) Links wide. The in Lots are each two Chains, 16¹/₂ Links long, & one (1) Chain wide. The lines bounding the Ends of the in Lots, are all parallel to Pearl Street. The out Lots are a Grave yard, lie on the West side of Herman Street. The out lots are designated in the above plat by Roman Numbers. The distance of their boundary lines is marked on the plat in Roman Numbers. The Grave yard contains one Nine hundredth Acre, but Lot 1, contains Sixty eight (68) Aeres, but Lot 2, contains Eighty nine (89) hundredth Aeres, & Lot 3 contains (89) hundredth Aeres. The Allys are each twenty five Links wide & run as designated on the plat. The Allys on the South side of this Addition, is not intended to be made part of this Addition inasmuch as the Land upon which it has been laid out, does not all belong to B. S. Schraeder, at whose instance the Survey was made. A corner Stone is planted at the North East corner of the lot N^o 14, & at the South East corner of in Lot N^o 24. A corner Stone is also planted at the South East corner of each of the out Lots of Grave yard. The line bounding the West side of the Grave yard, & out Lots, bears N 15^o E. I certify the foregoing description & delineation of the North Addition, of the Town of Brimm to be correct. This 23rd day of July A.D. 1845.

So All So Whom it may concern, know ye that J. Bernara & Schraeder, of the County & State of Ohio have caused a portion of my Land to be laid out, into in Lots, out Lots, Streets Allys &c. to be known as the North Addition to the Town of Brimm, as described in the within plat, & description, & that it is my intention to have the same recorded, as the Statutes of the State of Ohio provides.
