

Incorporated Village of Wapakoneta Ohio To the Honorable Commissioners of Auglaize County, Ohio: Your petitioners, the Mayor and Common Council of the incorporated village of Wapakoneta, respectfully represent that at their regular session of said Council, by a unanimous vote they passed an ordinance annexing the following described territory to said village as part of the Corporation thereof to wit: Commencing at S.W. cor. Section 28, Town 5 Range 6 East, thence East 10 chains, thence North 20.095 chains, thence East 30.16 chains, thence North 19.78 chains, thence West 40 chains to N.W. cor of S.W. gr. Section 28 Town 5 Range 6 East, including the Meekins Subdivision of Lots Nos 1 to 20 inclusive, and J. A. Sagers East addition of out lots Nos 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64 & 65, also, Elliotts Subdivision of Lots Nos 1 to 5 inclusive, Also commencing at the South W. corner, S.E. gr. of N.E. gr. Section 29 Town 5 Range 6 East running thence N. 14.95 chains, thence N. 60 chains, thence North 5.25 chains, thence N. 29.75 chains; thence S. 10 chains to the S.W. corner said Section, including Elliotts N.E. addition out lots Nos 14 to 24 inclusive, R. M. Murrays North addition out lots Nos 68 to 87, and lot No 109; and W. Crafts fraction No 1 in said Section 29; Also commencing at a point on the West line of the present Corporation where it crosses the Auglaize River thence down said river with the meanderings thereof to S.W. cor lot No 23 of Herbertitts Subdivision Lots; thence E. to the N.W. cor of S. Half N.E. gr. S 31 Town 5 Range 6 E. thence South 19.34 chains; thence E. 40 chains to E. gr. cor Sect 31 Town 5 Range 6 E including the Stoddards Subdivision Lots Nos. 1 to 14 inclusive; Herbertitts Subdivision Lots Nos 1 to 25; J. Sangers out lot No 67, and fractional out lots Nos. 2, 3, 4, 5 & 6, and S.E. fraction of Section 30 Town 5 Range 6 E.

A correct plat of said territory is herewith filed & marked "A". A copy of said ordinance is hereto attached & marked "B". Your petitioners therefore prays that such proceedings may be had by your Honorable body as may be necessary to perfect the annexation of said territory to said village.

"B" An ordinance annexing territory to the "Incorporated Village Wapakoneta Ohio."

Be it ordained by the Council of the Incorporated Village Wapakoneta Ohio, that the contiguous territory hereinafter named, known and designated as out lots, and Subdivision of out lots to the Incorporated Village Wapakoneta Ohio, shall be annexed for general Corporation purposes, and be made subject to all existing ordinances now or which may hereafter be in force, to wit:

II. Commencing at S.W. cor. Sect 28 Town 5 Range 6 East, thence East 10 chains, thence North 20.095 chains, thence East 30.16 chains, thence North 19.78 chain, thence West 40 chains to N.W. cor of S.W. gr. Sect 28 Town 5 Range 6 East, including the Meekins Subdivision of lots Nos 1 to 20 inclusive, and J. Sagers East addition of out lots Nos 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64 & 65, also, Elliotts Subdivision of lots Nos 1 to 5 inclusive.

Also commencing at the S W cor S E qr. of N E qr. Sect 29 Town 5 Range 6 East, running thence North 14.75 chains, thence West 20 chains, thence North 5.35 chains, thence West 39.78 chains, thence South 20 chains to the S W cor said section, including J Elliotts N E addition out lots Nos 17 to 24 inclusive, R McMurrays North addition out lots Nos 68 to 82, and lot 109, and H Crafts fraction No 1, said section 29; Also commencing at a point on the West line of the present Corporation where it crosses the Auglaize river, thence down said river with the meanderings thereof to S W cor lot No 23 of Herberts Subdivision lots, thence East to the N W cor of S half N E qr. Section 31 Town 5 Range 6 East, thence South 19.54 chains, thence East 40 chains to East qr. cor. Section 31 Town 5 Range 6 East, including H Stodolands Subdivision lots Nos 1 to 14 inclusive, Herberts Subdivision lots Nos 1 to 25, J Sawyers out lot No 6, and fractional out lots Nos 7, 3, 4, 5 & 6; and S E fraction of Sect 30 Town 5 Range 6 East.

Be it further ordained, that H. V. M. Fayton, is hereby appointed and authorized to prosecute all proceedings necessary to effect the annexation of the aforesaid territory for the uses and purposes therein mentioned.

Sect 29 Town 5 Range 6 East, running thence North 14.75 chains, thence W. 20 chains, thence N. 5.35 chains, thence W. 39.78 chains, thence S. 20 chains to the S W cor. said section, including J Elliotts N E addition of out Lots Nos 17 to 24 inclusive, R McMurrays North addition out Lots, Nos 68 to 82, and lot 109, and H Crafts fraction No 1, said section 29; Also commencing at a point on the W. line of the present Corporation where it crosses the Auglaize River, thence down said river with the meanderings thereof, to S W cor lot No 23 of Herberts Subdivision of Lots, thence East to the N W cor. of South half N E qr. Sect 31 Town 5 Range 6 East.

In the matter of annexation of territory to the Corporation of Hapsakonuta Ohio, this day came said Corporation by H. V. M. 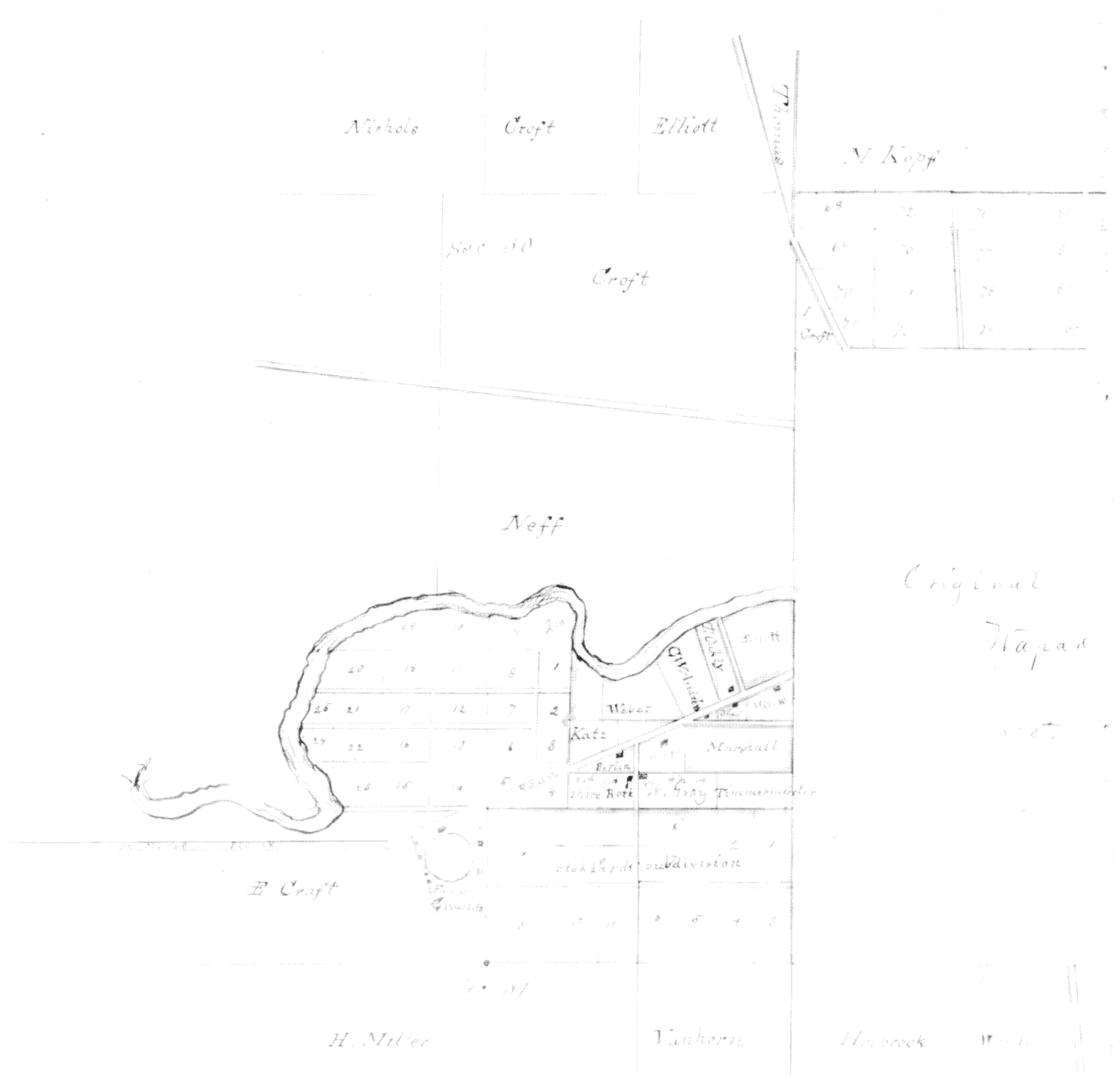

This case coming on to be further heard, upon the petition and accompanying papers, and the Commissioners of said County of Auglaize, finding that the same contains all the matters required, and that its statements are true, and that the Map or plat as filed in this case is accurately made, It is ordered by said Commissioners that said proposed territory as set forth in said petition and described in said Map or plat, be and the same is hereby annexed to, and made a part of the Incorporation of said village of Hapsakonuta. It is further ordered, that the Auditor proceed to make the rolls and receipts in this case as required by law.

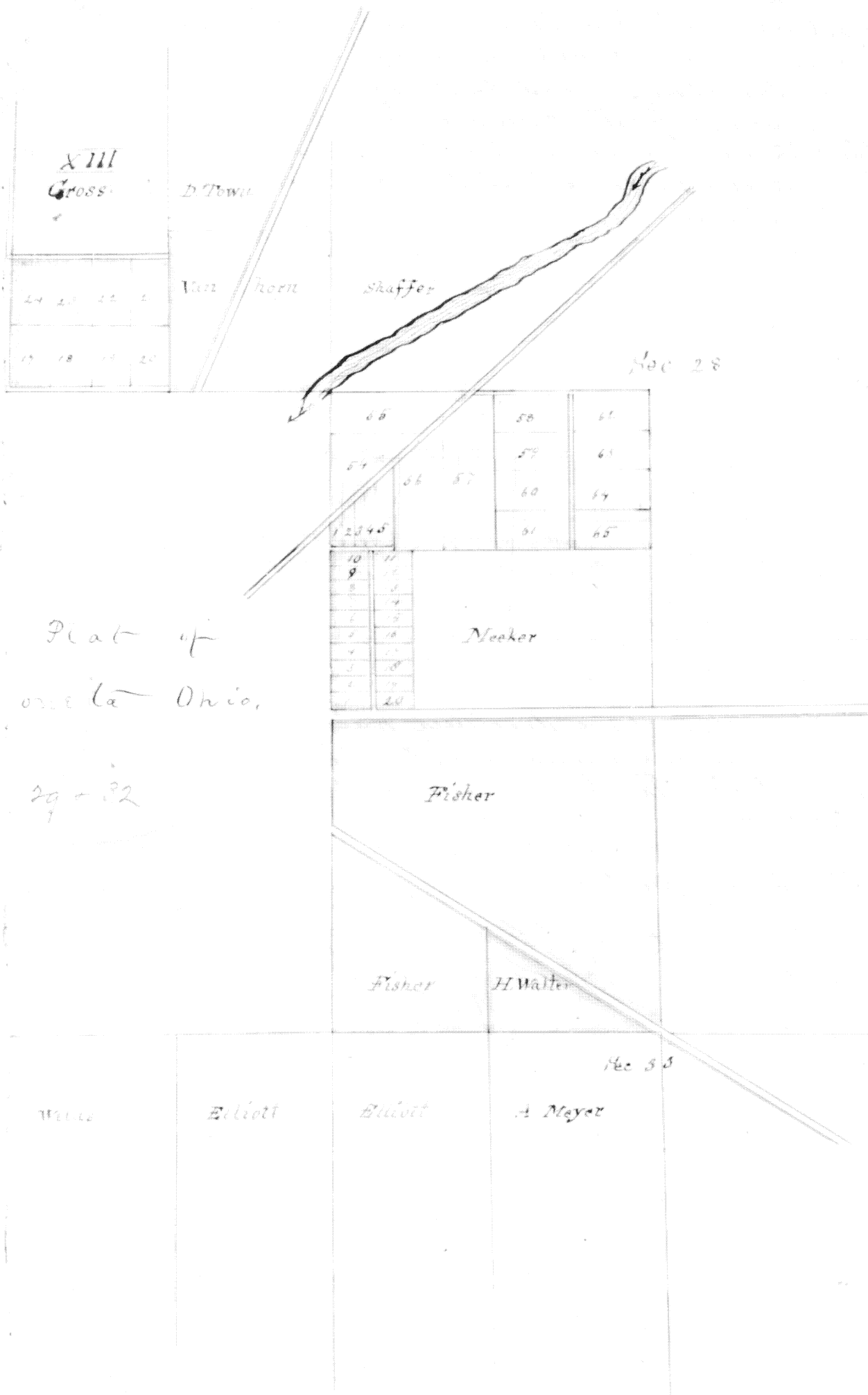
