

June 11th 1870. In the matter of the annexation of territory to the corporation of St Marys Auglaize County Ohio. This day came the said corporation by their agent T. C. Sawyer and presented a petition accompanied by an ordinance passed by the council of said village; also a plat of the territory proposed to be annexed in words and figures as follows to wit: To the commissioners Honorable of Auglaize County Ohio. Your petitioners the Mayor and common council of the incorporated village of St Marys Ohio, respectfully represent that at a regular session of said council by a unanimous vote they passed an ordinance annexing the following described territory to said village, as part of the corporation thereof to wit: All of that part of section three, township six, south of range four east in Auglaize County Ohio, not already included in the corporate limits of said village of St Marys Ohio, except fraction number one of said section, consisting of out lots number 1, 2, 3, 4, 5, 6, 7, 8, 9 & 10 of McKees and Scotts addition; also fractions of said section three being number 2, 3, 4, 5, 6, 7, 8, 9, 10, 21, 22, 26, 27, east part 27 west part and 28; and also of the north half of section ten in same town and range not already included in said corporation lying north of the Greenville road, and the lane running east from the intersection of the Regue and Greenville roads to the St Marys River thence meandering said river to the section line on the east side of said section, consisting of out lots number 1, 2, 3, 4, 5, 6, 7, 8, 11, 12 & 13 of Mitchells west addition; also out lots number 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 & 14 of Mitchells east addition; also fractions of said section ten of aforesaid number 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, and that part of lot 14 north of the lane. A complete plat of said territory is herewith filed marked "A". A copy of said ordinance is hereto attached marked "B".

Your petitioners therefore pray that such proceedings may be had by your Honorable body as may be necessary to perfect the annexation of said territory to said village. T. C. Sawyer, Attorney and agent for corporation.

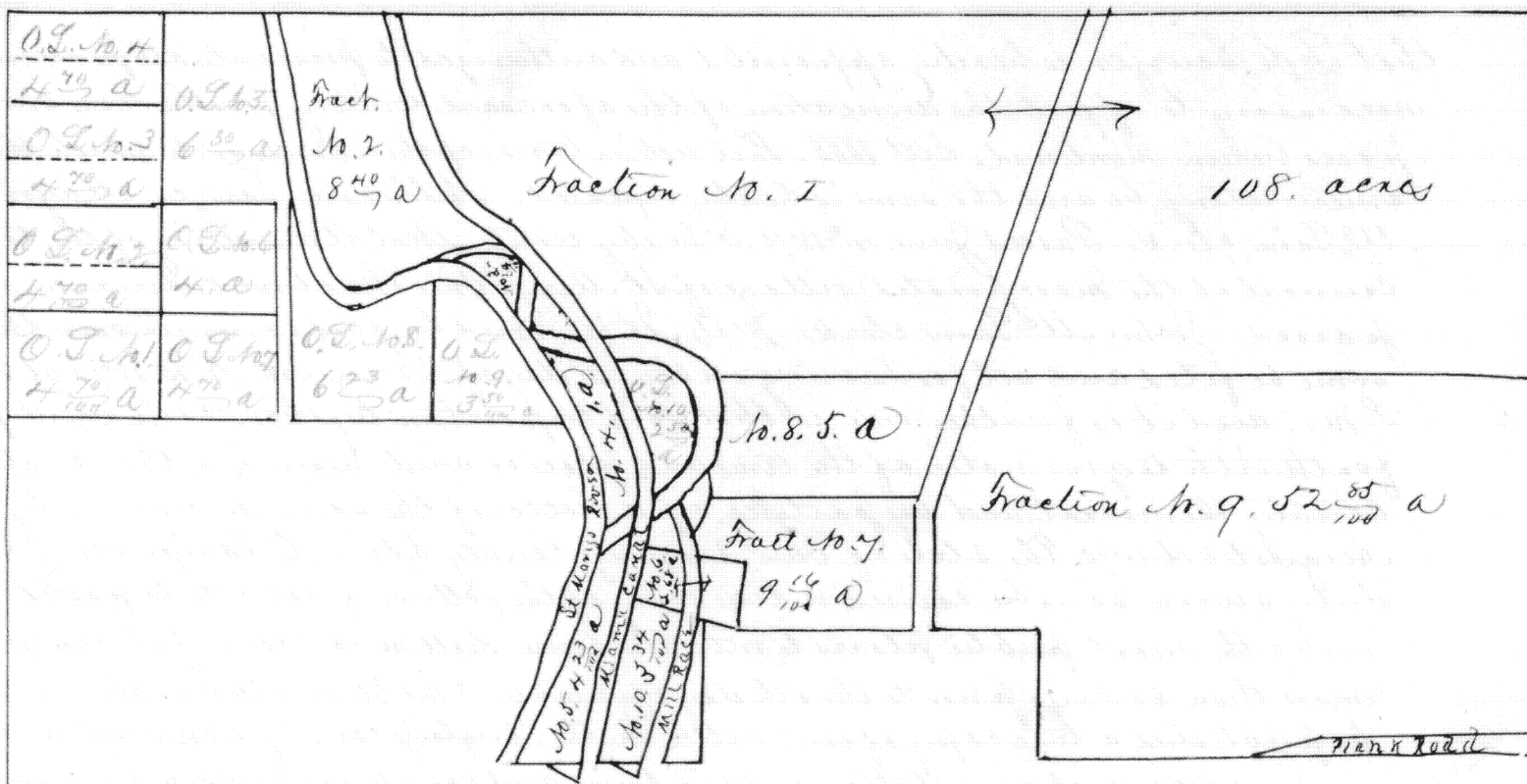
"B." An ordinance to - To amend section two of an ordinance entitled "an ordinance relating to the enlargement of the corporate limits" passed May 17th 1870. Be it ordained by the Council of the Incorporated village of St Marys Ohio, that section two of the above entitled ordinance be so amended as to read as follows, Sect II. Be it ordained by the Council of the Incorporated of St Marys Ohio, that contiguous territory hereinafter named known and described and designated as out lots and subdivisions of out lots, fractions and tracts of lands, to the Incorporated village of St Marys Ohio, shall be annexed for general corporation purposes, and be subject to all existing ordinances now, or which may hereafter be in force to wit: Sect. III. All of that part of section three (3) town six (6) south of range four (4) east in Auglaize County Ohio, not already included in the corporate limits of said village of St Marys Ohio, except fraction number one (1), consisting of out lots number 1, 2, 3, 4, 5, 6, 7, 8, 9 & 10, of McKee and Scotts addition - also: fractions of said section three being numbered 2, 3, 4, 5, 6, 7, 8, 9, 10, 21, 22, 26, 27, east part 27, west part and 28, and all of the north half of section ten (10) in said town and range, not already included in said corporation lying north of the Greenville road, and the lane running east from the intersection of the Regue and Greenville roads to the St Marys River, thence meandering said river to the section line on the east side of said section, consisting of out lots number 1, 2, 3, 4, 5, 6, 7, 8, 11, 12 & 13, of Mitchells west addition; also numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 and 14 of Mitchells east addition; also fractions of said section number ten (10) of aforesaid, number 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, and the part of number 14 north of the lane. Sect. IV. Be it further ordained

that J. L. Sawyer is hereby appointed and authorized to prosecute all proceedings necessary to effect the annexation of the aforesaid territory for the uses and purposes herein mentioned, Sect 11111. That section two (2) of the ordinance to which this is amendatory be and the same is hereby repeated. William Sawyer, Mayor, John McTain clerk. Passed June 4th 1870. I hereby certify that at a meeting of the town council of the Incorporated village of St. Marys Ohio the above ordinance was passed. John McTain clerk. Be it ordered by said commissioners that the same be filed and set for hearing on the 8th day of August A.D. 1870 at 2 O'Clock P.M.; and it is further ordered that said corporation by their said agent proceed forthwith to give notice of the time and place of said hearing in the Auglaize County Democrat, and by posting up a notice of the same as required by law. August 8th 1870. The state of Ohio Auglaize County S.S: J. L. Sawyer being first duly sworn, says he caused a true copy of the following notice to be posted up in one of the most public places to wit: the town hall in said town of St. Marys for more than 60 days prior to the 8th day of August A.D. 1870, and that he also caused to be published a true copy of said notice in the "Auglaize County Democrat" a newspaper of general circulation in said town and county of Auglaize for more than 60 days prior to the 8th day of August A.D. 1870. J. L. Sawyer, Sworn to before me, and signed in my presence this 8th day of August A.D. 1870. C. P. Davis clerk, Com. P. C.

In the matter of annexing territory to the town of St. Marys, this matter coming on to be heard, J. L. Sawyer, Counsel for corporation produced a notice with proof of service of the same as required by law in words and figures as follows: To all whom it may concern. You are hereby notified that on the 6th day of June A.D. 1870, the corporation of St. Marys through their common council, in pursuance of an ordinance passed by said council at a regular session thereof filed their petition in the Auditor's office in said county, asking the commissioners thereof to annex the territory hereinafter described to said corporation and to make said territory a part thereof to wit: all that part of section three (3) town six (6) south of range four (4) east, in Auglaize county Ohio, not already included in the corporate limits of said village of St. Marys Ohio, (except fractions number one (1)) consisting of and lots number 1, 2, 3, 4, 5, 6, 7, 8, 9 & 10, of McKee and Seath's addition; also fractions of said section three (3) being numbered 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 22, 26, 27, east part, 27 west part and 28; also all of the north half of section ten (10) in said town and range not already included in said corporation lying north of the Greenville road, and the lane running east to the St. Marys river, thence meandering said river to the section line, on the east side of said section, containing of and lots number 1, 2, 3, 4, 5, 6, 7, 8, 11, 12, and 13 of Mitchells west addition; also numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 and 14 of Mitchells east addition; also fractions of said section number ten (10) aforesaid numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, and the part of number fourteen north of the lane: that the same is set for hearing on the 8th day of August A.D. 1870, at 2 O'clock P.M. J. L. Sawyer, June 6th 1870. Agent and attorney for corporation.

This cause coming on further to be heard upon the petition and accompanying papers, and the commissioners of said county of Auglaize finding that the same contains all the matters required and that its statements are true and that the map or plat as filed in this case is accurately made. It is therefore ordered by said commissioners that said proposed territory as set forth in said petition and described in said map or plat be and the same is hereby annexed to be made a part of the Incorporated village of St. Marys Ohio. It is further ordered that the Auditor proceed and make the records and transcript in this case as required by law; J. E. McFarland, Jno B Kruse, J. Sammetinger, Commissioners.
