Plat of Conrad Schummel Survey of Land of the North half of section Number 21 and a part of NE 1/4 of section 20, belonging to the following persons; Conrad Schummel Lot No. 1 bounded and described as follows, The above named lot lying in the North East quarter of section twenty one. Commencing my survey on the North East corner of said section, thence running South 40 chains 50 Licks on the east line of said Sect. twenty one. Thence west 6 chains, 25 L. on the center line of S. Sect.; thence North 40 ch. 50 L. where the line strikes the section line between section Av. 21 & 16; thence East 6 chains 25 L. to the North East cor. of section 21. This lot contains 25 $\frac{5}{100}$ acres. Carl Spiegelburg Lot No. 2. lying in the North East quarter of section 21. Commencing at the North West cor. of lot Av. 1, thence running South 40 chains 50 L. to the center line of Section No. 21. Thence angling to the West and running to the center line 13 chains 75 L. thence North 40 chains 50 L. to the section line between sections 21 & 16; thence East 13 chains 75 L. on 8 $\frac{1}{2}$ section line to the beginning. This lot contains 55 $\frac{68}{100}$ acres. Michael Upperman, Lot No. 3. bounded and described as follows. The above named lot lying in the North East quarter of section Av. 21, commencing at the North West cor. of lot Av. 2. thence running South 40 ch. 50 L. to the center line of said section; thence West 5 chains 15 L. on said line, thence North 40 chains 50 L. thence E. 5 ch. 16 L. to the beginning. This lot contains 20 $\frac{3}{100}$ acres. Andrew Eberle lot No. 4. Commencing at the North West corner of said lot No. 3. thence running South 40 chains 50 L. to the center line of said section 21; thence West 8 chains 50 L. on said center line; thence North 40 chains 50 L. to the north line of said section thence East 8 chains 50 L. to the beginning. This lot contains 32 $\frac{4}{100}$ acres; Joseph Haageman, Lot No. 5 lying partly in the NE 1/4 and partly in the NW 1/4 of section No. 21. Commencing at the North West corner of lot No. 4. thence running West 24 chains, to the North line of section 21. thence South 23 chains 25 L. thence East 23 chains 75 L. to the West line of lot No. 4; thence North 20 chains 50 L. to the place of beginning. This lot contains 52 acres; George Schaffer lot No. 6. lying partly in North East quarter and partly in the North West quarter of section 21. Commencing at South East cor. of lot No. 5 thence running South 20 ch. on the West line of lot No. 4. thence West 21 chains and 38 L. to the east center line of section 21. thence North 17 chains 45 L. to the south line of lot No. 5. thence East 21 ch. 25 L. on

the South line to the beginning. This Lot contains 40 acres. John Fries
Lot No. 7. Commencing at the Section line between section 21 & 20, thence
18 chains and 50 links farther to the Sidney and Wapakoneta Road, thence
South 15 chains in section 20 on the East line of said Road, thence East
46 chains 66 links, to the section line between section 20 & 21, thence on
the same course 22 chains and 42 links to the West line of Lot No. 5, thence
North 15 chains on said line to the North West corner of Lot No. 5, this
lot contains 60 acres. I believe to be correctly surveyed, according
to the Plat above, November 8th 1850.
