

G. W. Holbrook South Addition to the Town of Wapakoneta

As laid out on the south East part of the west half of the north East quarter of Section thirty two (32), Town five (5) South Range six (6) East. Commencing at the South East corner of Skinner Alley and Ohio Street, thence one hundred and fifty feet to Vine Street, from the South side of said Street, Lot No. 784 is 160 ft. square, Lot 785 is 166 1/2 feet to the north side of Race Street, thence East on Race Street 150 feet to Lot 782 which is 166 1/2 feet by 166 1/2 feet, Lot 783 is 166 1/2 feet on Vine Street by 150 feet on Court Street. From Race Street on the East side of Ohio Street there is added on the West end to Lot 781, 205 ft. off of the East side of Ohio Street, making Ohio Street only 205 ft. wide from Race Street across Lots Nos. 781, 780, 779 & 778, Lot 742, is 47 3/4 feet on South side of Vine Street and 47 feet on the alley. Lot No. 753 is 47.63 on the alley and 50 feet on Race Street. No. 781 is 158 1/2 ft. by 336 Lot 780 is 188 1/4 ft. by 336. Lot No. 779 is 188 1/4 ft. by 336. Lot 778 is 208 1/4 ft. by 336. All the regular lots are 50 ft. front by 150 ft. deep, except Lot 741 which is 50 ft. on Skinner Alley and 58 1/2 ft. hundredths on Vine St. Ohio Street is 66 feet wide to the corner of Lot 781, thence 20 feet to the South West corner of Lot No. 778. The alleys are all 16 1/2 feet wide. Vine, Race and Plum Streets are 60 feet wide each, South Street is 50 feet wide. The Streets and Alleys do not cross at right angles but vary 26 minutes of a degree to correspond with the Streets and Alleys in the original part of the Town. October 30th 1869.
