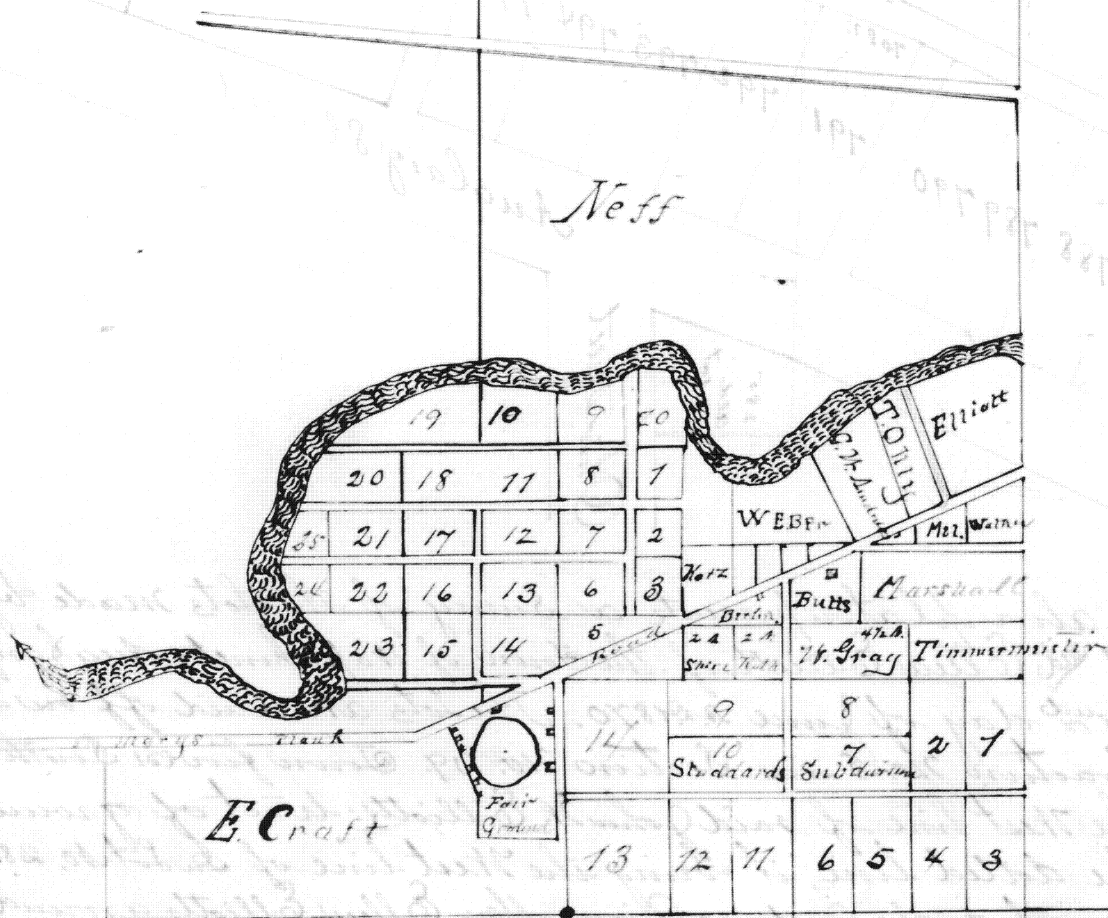
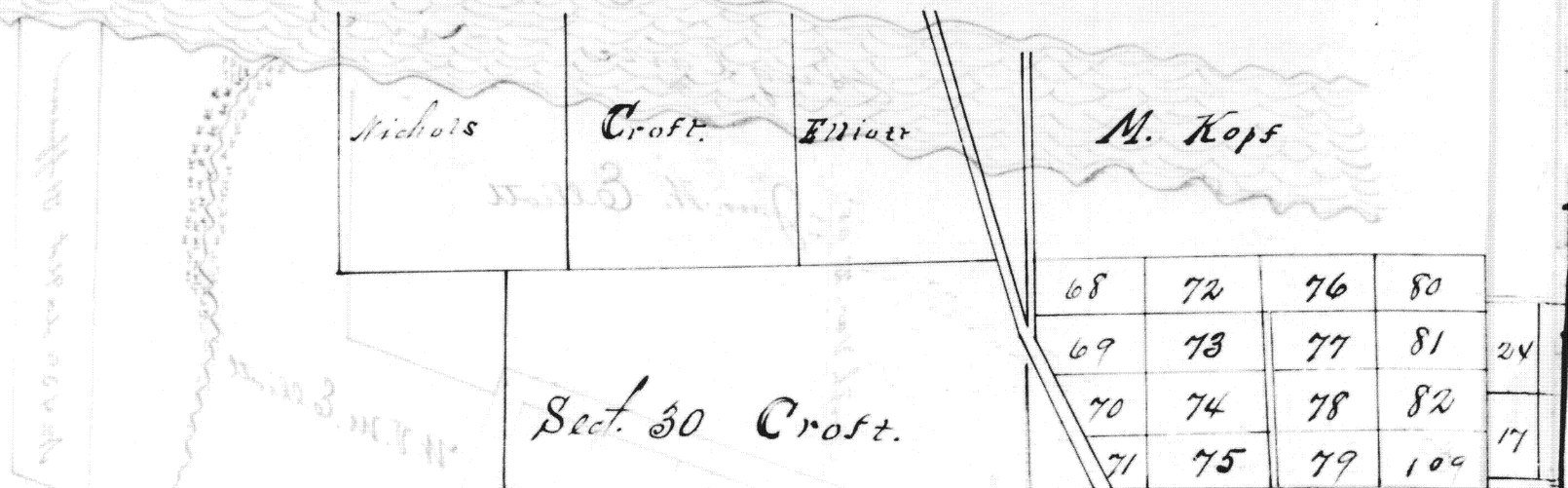
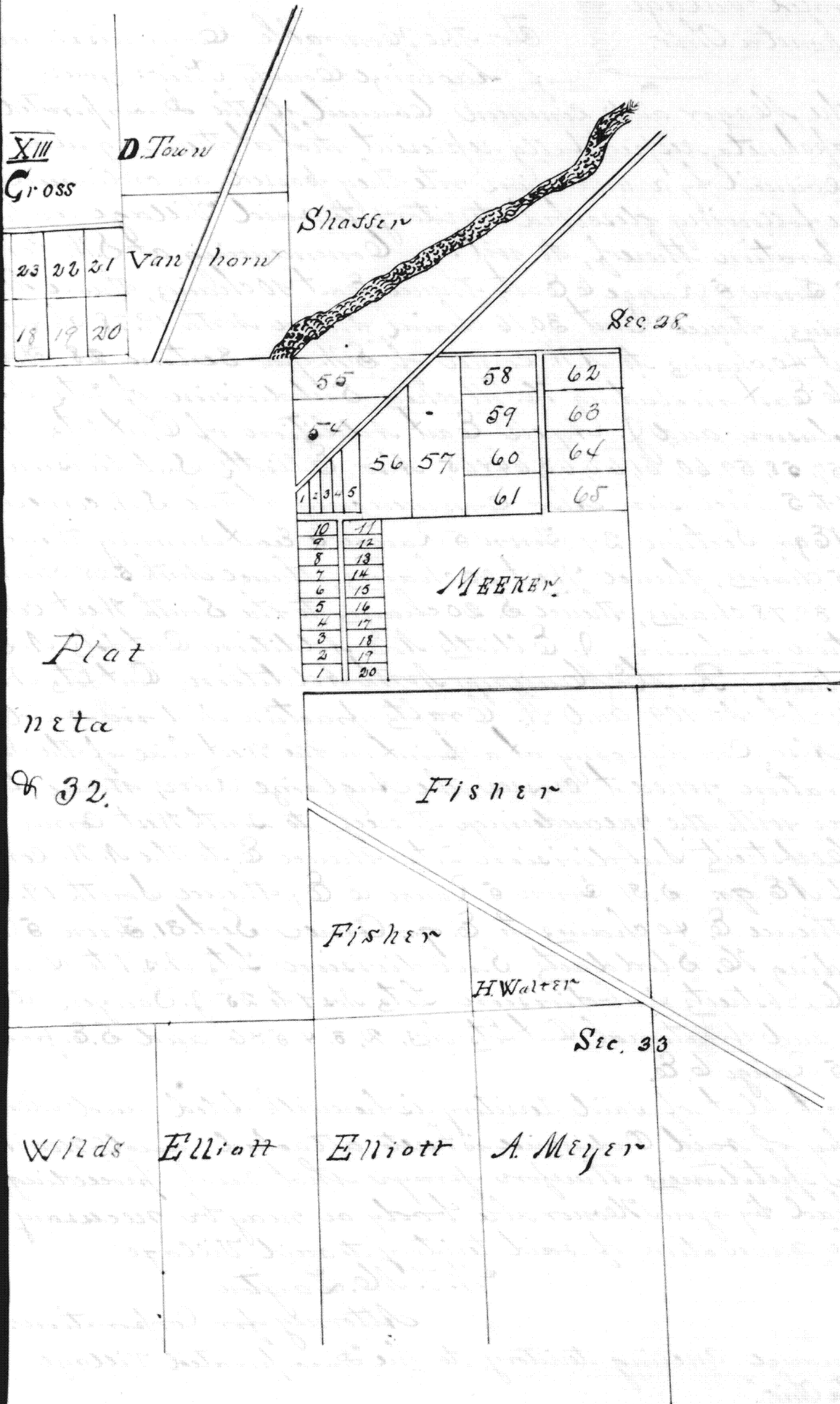

To The Honorable Commissioners of Auglaize County Ohio: Your Petitioners, the Mayor and Common Council of the Incorporated Village of Wapakoneta respectfully represent that at their regular session of said Council by a unanimous vote they passed an ordinance annexing the following described territory to said Village as part of the corporation thereof, to wit: Commencing at S.W. corner Section 28, Town 5 Range 6 East, thence East 10 chains, thence North 20.095 chains, thence East 30.16 chains, thence North 19.78 chains, thence West 40 chains to N.W. corner of S.W. qtr. Section 28, Town 5 Range 6 East including W. Meches Subdivision of Lots Nos. 1 to 10 - inclusive, and J. Ayer's East Addition of Out Lots Nos. 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64 & 65. Also Elliott's Subdivision of Lots Nos. 1 to 5 inclusive. Also commencing at the S.W. corner S. E. qtr. of N.E. qtr. Section 29 Town 5 Range 6 East running thence North 14.75 chains, thence West 20 chains, thence North 5.25 chains thence W. 39.78 chains, thence S. 20 chains to the South West corner said Section inclusive. J. Elliott's N. E. Addition Out Lots Nos. 17 to 24 inclusive. R. M. Mearns North Addition, Out Lots Nos. 68 to 82 and Lot No. 109, and W. Crafts fraction No. 1 in said Section 29. Also commencing at a point on the West line of the present Corporation where it crosses the Auglaize River, thence down said River with the meanderings thereof to South West corner Lot No. 23 of Kerbstreit's Subdivision Lots; thence E. to the N. W. corner of S. half N.E. qtr. S. 31 Town 5 Range 6 E.; thence South 19.84 chains, thence E. 40 chains to E. qtr. Corner Sect. 31. Town 5 Range 6 E. including W. S. Loddarts Subdivision Lots Nos. 1 to 14 inclusive. Kerbstreit's Subdivision Lots Nos. 1 to 25. J. Sawyer's Out Lot No. 67 and fractional Out Lots Nos. 2, 3, 4, 5 & 6, and S. E. fraction 30 Town 5 Range 6, E.

A correct plat of said territory is herewith filed and marked "A" a copy of said Ordinance is hereto attached and marked "B". Your petitioners therefore prays that such proceedings may be had by your Honorable body as may be necessary to perfect the annexation of said territory to said Village.

"B" An Ordinance annexing territory to the Incorporated Village Wapakoneta Ohio.

I. Be it Ordained by the Council of the Incorporated Village Wapakoneta Ohio that the contiguous territory herein after named known and designated as Out Lots and Subdivision of Out Lots to the Incorporated Village Wapakoneta Ohio shall be annexed for general Corporation purposes, and be made subject to all existing ordinances now or which may hereafter be in force, to wit:

II Commencing at S.W. Cor. Sect. 28. Town 5 Range 6 East; thence East 10 chains, thence North 20.095 chains, thence East 30.16

Chains, thence North 19.78 chains, thence West 40 chains to N.W. corner of S.W. qr. Sect. 28 Town 5 Range 6 East including McMeekes Subdivision of Lots Nos. 1 to 20 inclusive and J. Ayer's East Addition of Out Lots Nos. 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64 & 65. Also Elliott's Subdivision of Lots Nos. 1 to 5 inclusive, Also Commencing at the S.W. Corner S.E. qr. of N.E. qr. Sect. 29. Town 5 Range 6 East running thence North 14.75 chains thence West 20 chains, thence North 5.25 chains, thence West 39.78 chains, thence South 20 chains to the South West Corner said section including J. Elliott's NE Addition Out Lots Nos. 17 to 24 inclusive, B. McMurphy North Addition Out Lots Nos. 68 to 82 and Lot No. 109, and W. Crafts fraction No. 1. said Section 29, Also Commencing at a point on the West line of the present Corporation where it crosses the Auglaize River, thence down said River with the meanderings thereof to S.W. Cor. Lot No. 23 of Keesbetrity Subdivision Lots, thence East to the N.W. Cor. of S. 1/2 N.E. qr. Section 31 Town 5 Range 6 East, thence South 19.84 chains, thence east 40 chains to East qr. Cor. Sect. 31 Town 5 Range 6 East including McStoddards Subdivision Lots Nos. 1 to 14 inclusive, Keesbetrity Subdivision Lots Nos. 1 to 25, J. Sawyer's Out Lot No. 67, and fractional Out Lots Nos. 2, 3, 4, 5 & 6, and S.E. fraction of Section 30, T. 5 R. 6 E.

### III

Be it further ordained that W. H. M. Layton is hereby appointed and authorized to prosecute all proceedings necessary to effect the annexation of the aforesaid territory for the uses and purposes therein mentioned.

I hereby certify that at a regular meeting of the Town Council of the Incorporated Village of Wapakoneta Ohio, the above ordinance was passed.

To all whom it may concern: You are hereby notified, that, on the 10<sup>th</sup> day of March A.D. 1870 the Corporation of Wapakoneta through their Common Council in pursuance of an ordinance passed by said Council at a regular meeting thereof, filed this petition in the Auditor's Office in said County asking the Commissioners thereof to annex the territory herein after described to said Corporation and to make said territory a part thereof, to wit:

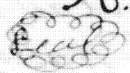

In the matter of annexation of territory to the Corporation of Wapakoneta, Ohio. This day came said Corporation by W. V. M. Layton their agent and presented a petition accompanied by an Ordinance passed by the Council of said Village, also a plat of the territory proposed to be annexed. It is ordered by the Commissioners that the same be set for hearing on the 18<sup>th</sup> day of May 1870 at 9 O'clock A.M. It is further ordered that said Corporation by their said agent forthwith proceed to give notice of the time and place of said hearing in the Auglaize County Democrat and by posting up a notice of the same as required by law. May 18<sup>th</sup> 1870.

In the matter of annexing additional territory to the town of Wapakoneta, Ohio. This matter coming on to be heard this day, W. V. M. Layton Counsel for Corporation produced a notice with proof of the service of the same as required by law; This came coming on to be further heard upon the petition and accompanying plat and papers. And the Commissioners of said County of Auglaize finding that the same contained all the matter required and that its statements are true, and that the map or plat on filed in this case accurately made. It is ordered by said Commissioners that said proposed territory as set forth in said petition and described in said map or plat

by and the same is hereby annexed to, and made a part of the Incorporation of said Village of Wapakoneta. It is further ordered that the Auditor proceed to make the records and transcript in this case as required by law.
