

Out Lots Reumbered St. Marys.

Record of Renumbering of Out Lots in St. Marys.

In pursuance of an Act entitled "An Act Authorizing the Numbering of Lots in any City Town or Borough in this State to be revised" passed February 2nd 1848. The Auditor and Recorder in conjunction with B. Suttles, appointed by the Council of St. Marys, met in the Auditors Office in said County on the 28th day of May A.D. 1880, and proceeded to revise the Number of all the Out Lots of said Town, so as to have but one consecutive series of Number of Out Lots, as follows, to wit:
