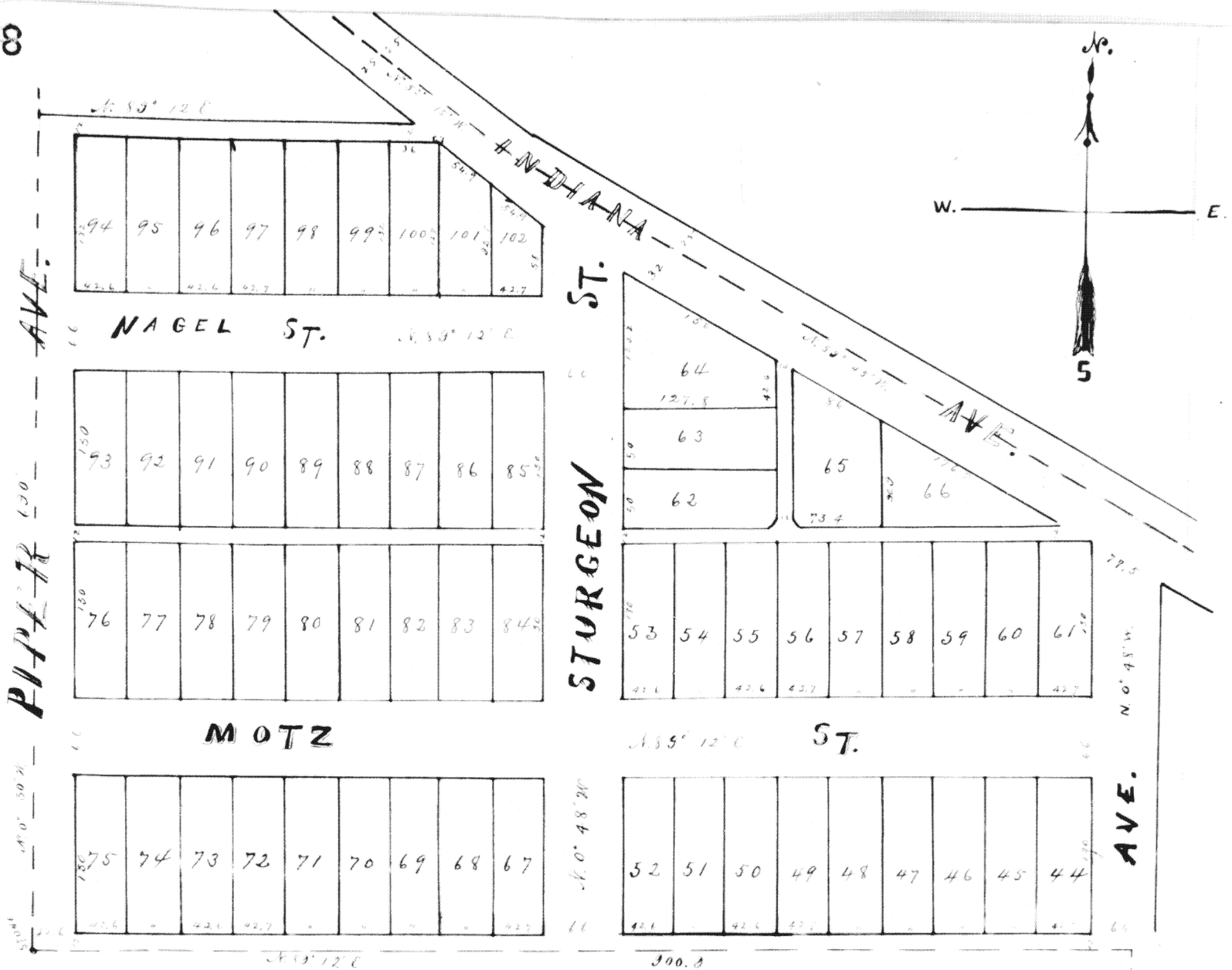

Bearings given are Magnetic. Boundaries are indicated in feet & hundredths.

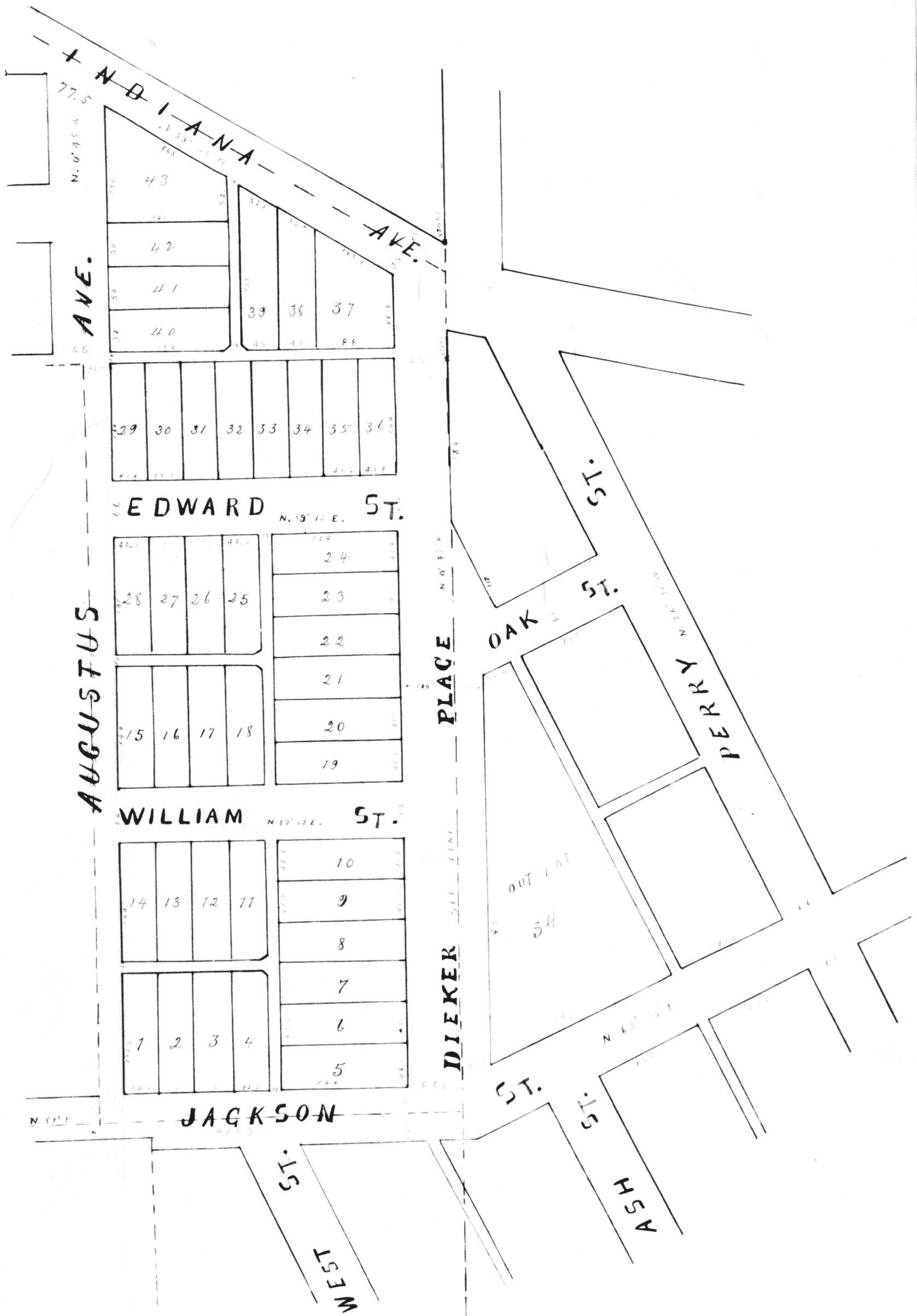
