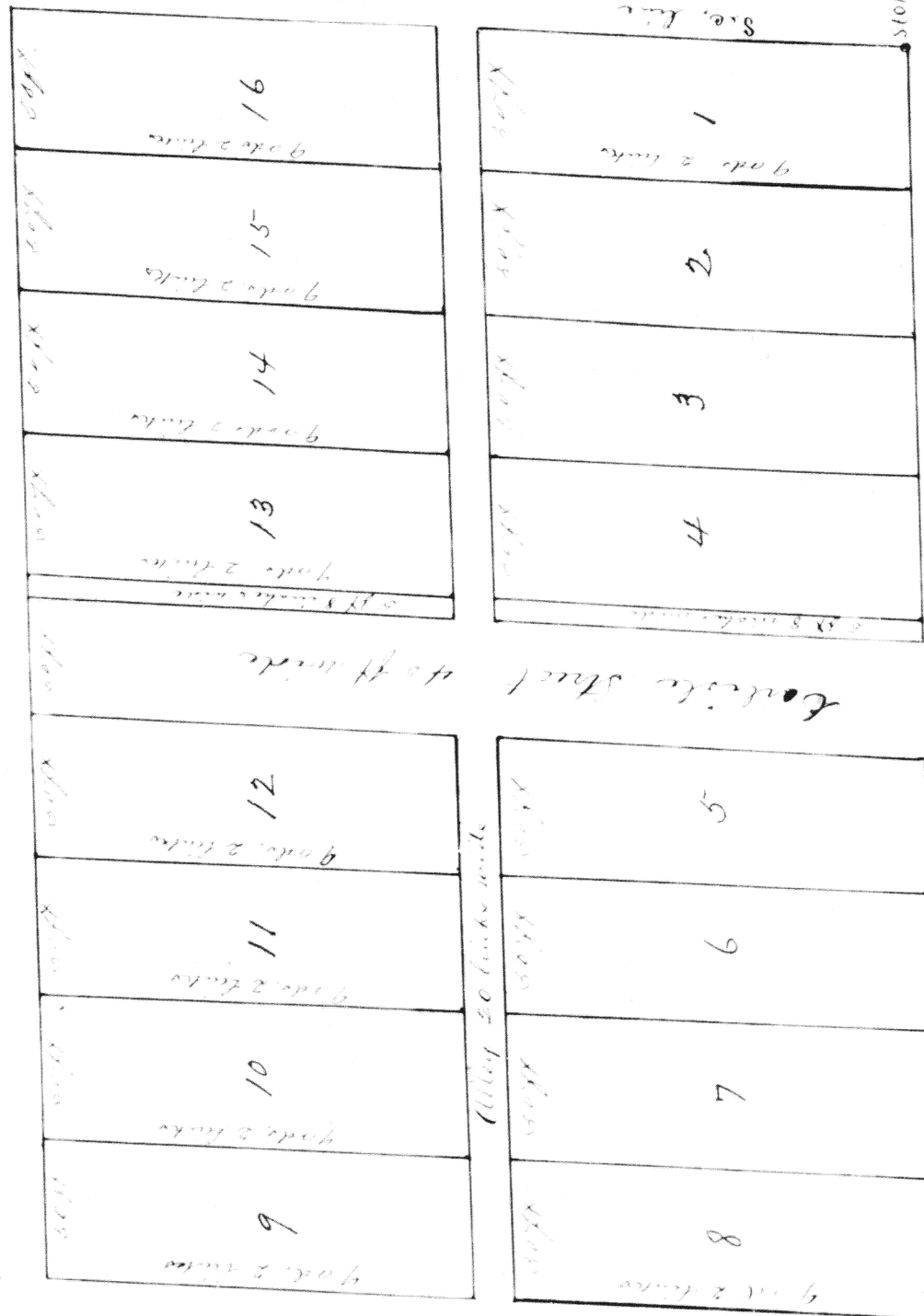
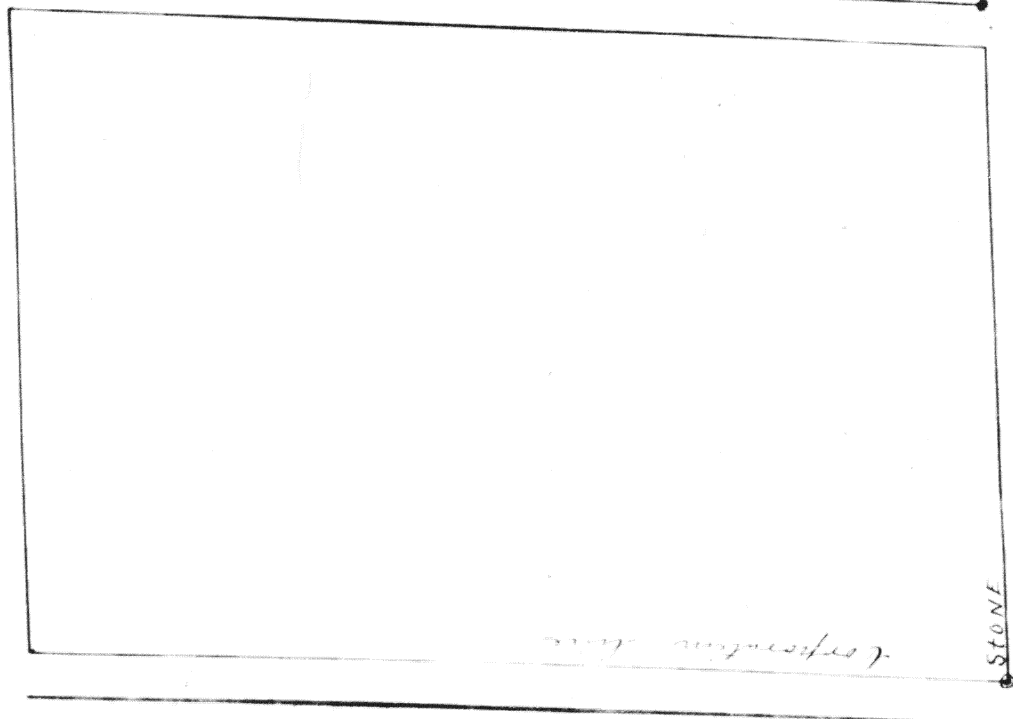


Cinderwille. Cyra Helongs West addition.

The above plat represents a fraction of the north east quarter of the north east quarter of section number thirty four (34) Township four (4) South Range six (6) east, Commencing at a point on the section line twelve (12) rods and seventeen (17) links north of the south east corner of the north east quarter of section thirty four (34) Township four (4) South Range six (6) east from thence south $85^{\circ} 49'$ west 1145 ft 8 inches thence north 18 rods and twenty four links, thence north $85^{\circ} 49'$ east 1145 ft 8 inches to the section line, thence south on section line 18 rods and 24 links to place of beginning. The foregoing tract of land has been surveyed into lots as an addition to the village of Cridersville, Auglaize County, Ohio - at the request of Ezra Delong.

Width of Streets and alleys are shown; Also the size of each lot. A monument is placed at the south east corner of lot number one; also at the south west corner of lot number eight.
