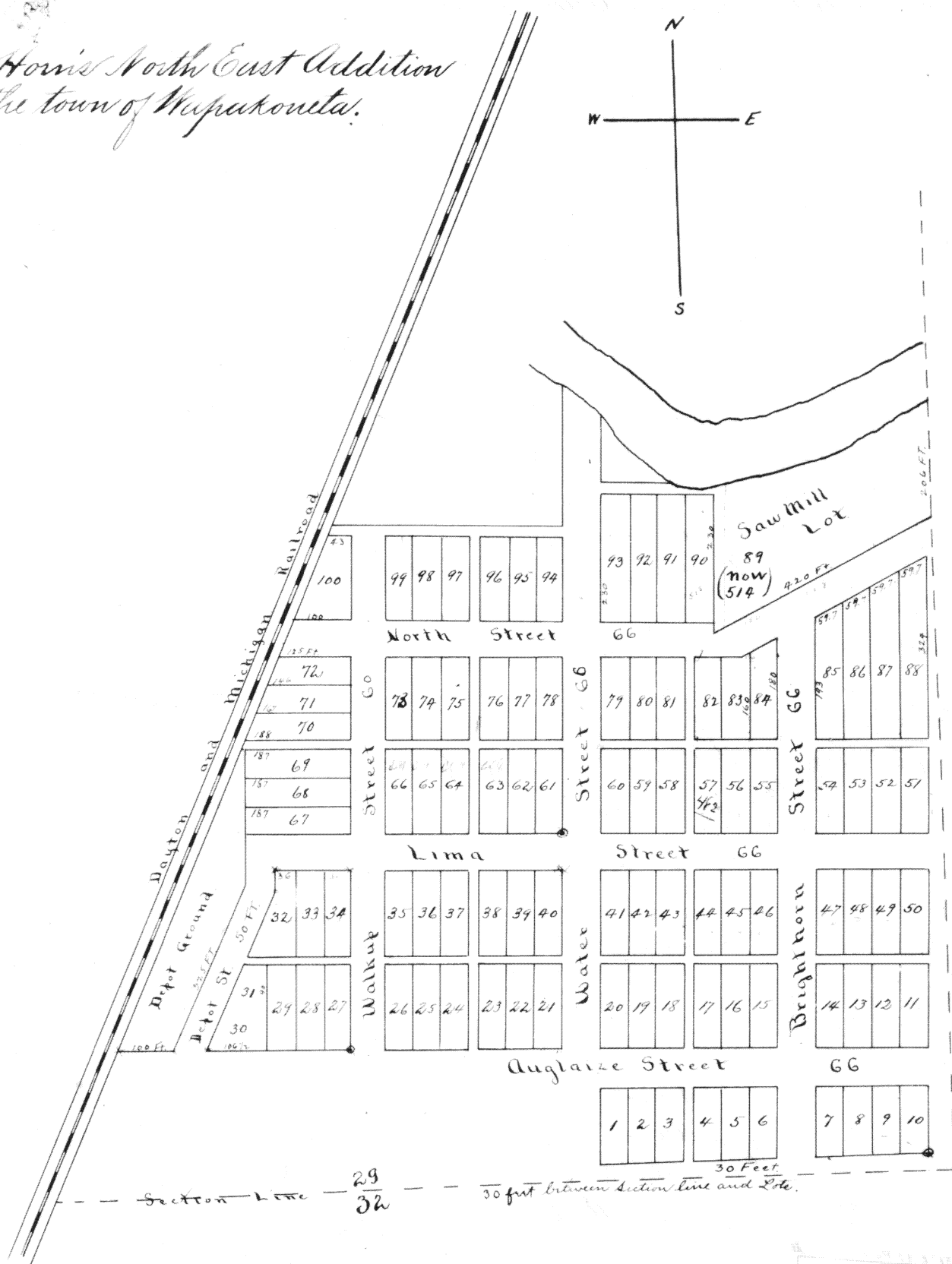


*Van Horn's North East Addition
to the town of Wapakoneta.*



The above plat represents a new and extended survey of Van Horn's East Addition to the Town of Wapakoneta made in October 1857 at the instance of Mr. A. Van Horn and the heirs of James Elliott deceased, and embraces a part of the west part of the south east fractional quarter of Section 29, Town 5 south, Range 4 east. The alleys are 16 1/2 feet wide. Streets are 66 feet wide, except Depot Street which is 50 feet and Walkup street which is 60 feet wide. All lots are 50 feet by one hundred and fifty, except where otherwise marked on the plat. Stones are planted at the South East corner of Lots No. 10, 27 and 61. The Streets and alleys cross each other at right angles except where shown on this plat. I do hereby certify the above to be a correct plat of the survey of said Addition made on the grounds. *John Cutler*

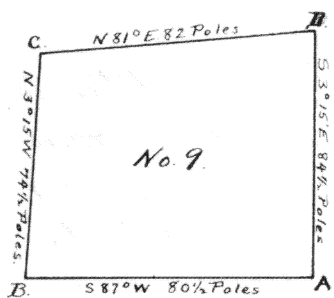

Plat and field notes of the South West quarter of the North East fractional quarter of Sect. 25 in Township 6 south of Range 7 east, bounded as follows:

See letter A stake from whence a hickory 14 in. diam. bears south 14 1/2 W 14 links and an ironwood 6 in. diam bears S. 70° W 6 1/2 links; thence South 87° W 80 1/2 rods to a stake from whence an ash 6 in. bears S. 70° N 12 links distance. Do. 8 in. diam. bears N 27° E 14 links; thence N 3° 15' W 74 1/2 poles to a stake in the boundary line, from thence A. S. ash 6 in. diam. bears S. 32° E 24 links. A hickory 4 in. diam. bears N 24° W 15 links. thence with the boundary line N. 81° E 82 poles to a stake a beech 14 in. diam bears S 70° W 20 links. Ash 8 in. diam. bears S 61° E 20 links. thence S 3° 15' E. 84 1/2 poles to the beginning containing 40 acres, as surveyed by me on the 12th day of November 1844 for the heirs of Joseph Line deceased.
