

G. W. Holbrook's South Addition to the Town of Wapakoneta.

As laid out on the south east part of the West half of the North east quarter of Section thirty two (32), town five (5) south, range six (6) east. Commencing at the south east corner of Skinner Alley and Ohio Street thence one hundred and fifty feet to Vine Street, from the South side of said street. Lot No. 784 is 150 ft. square. Lot 785 is 166½ ft. to the north side of Race street, thence east on Race street 150 ft. to Lot 782 which is 166½ ft. by 166½ ft. Lot 783 is 166½ feet on Vine street by 150 ft. on Court street. From Race street on the east side of Ohio street there is added on the west end to Lot 781, 20 ft. off of the east side of Ohio Street, making Ohio street only 20 ft. wide from Race street across lots Nos. 781, 780, 779 + 778. Lot 742 is 41 ³⁸/₁₀₀ feet on south side of Vine street and 47 feet on the Alley. Lot No. 753 is 47.63 on the alley and 50 ft. on Race street. No. 781 is 158½ ft. by 336. Lot 780 is 188¼ by 336. Lot 779 is 188¼ ft by 336. Lot 778 is 208¼ ft. by 336. All the regular lots are 50 ft. front by 150 ft. deep except lot 741 which is 50 ft. on Skinner Alley and 55 ⁶³/₁₀₀ ft. on Vine street. Ohio street is 66 ft. wide to the corner of Lot 781, thence 20 feet to the south west corner of Lot No. 778. The alleys are all 16½ feet wide. Vine, Race and Plum streets are 60 feet wide. South street is 50 feet wide. The streets and alleys do not cross at right angles but vary 26 minutes of a degree correspond with the streets and alleys in the original part of the town. 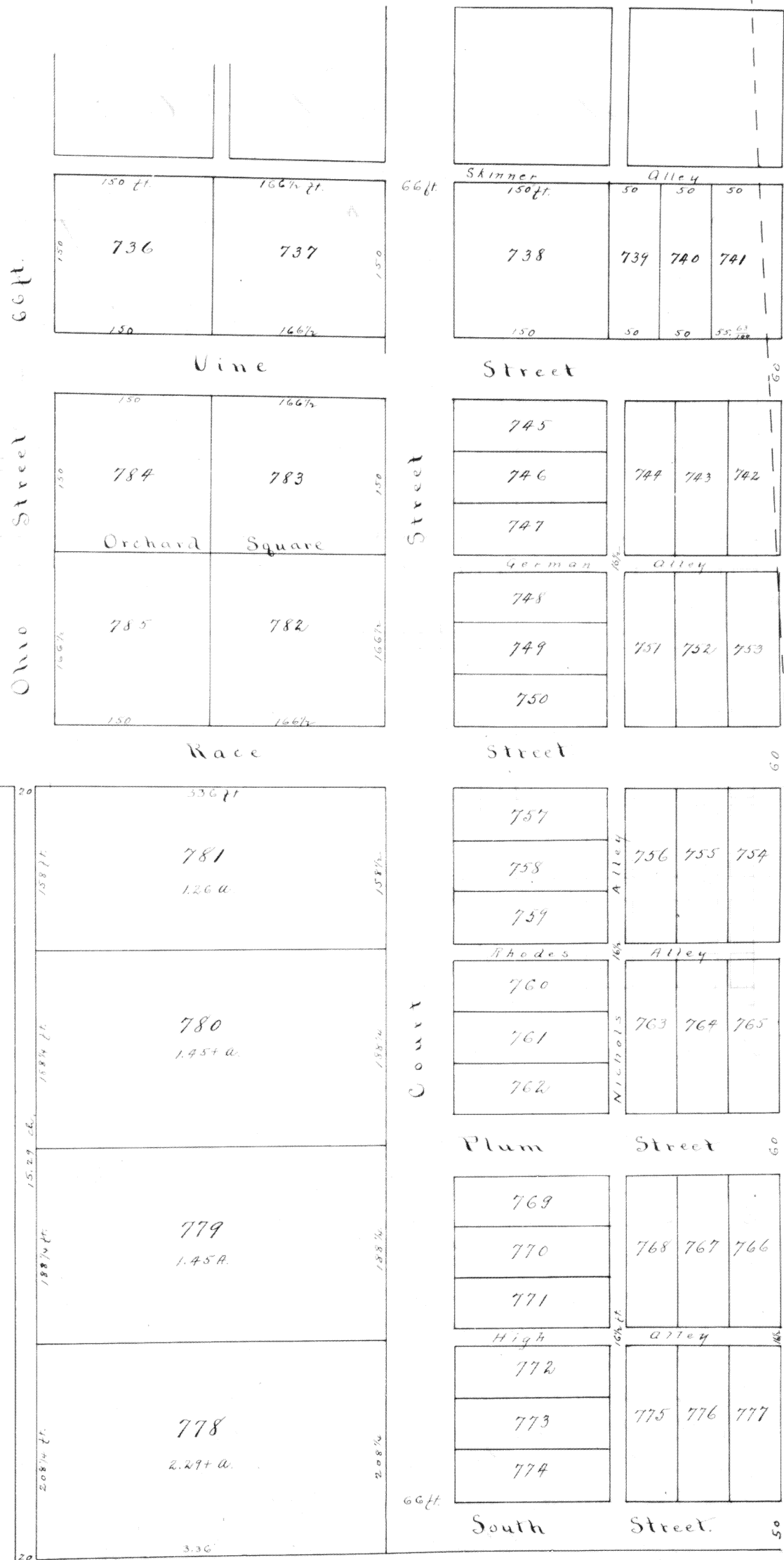
