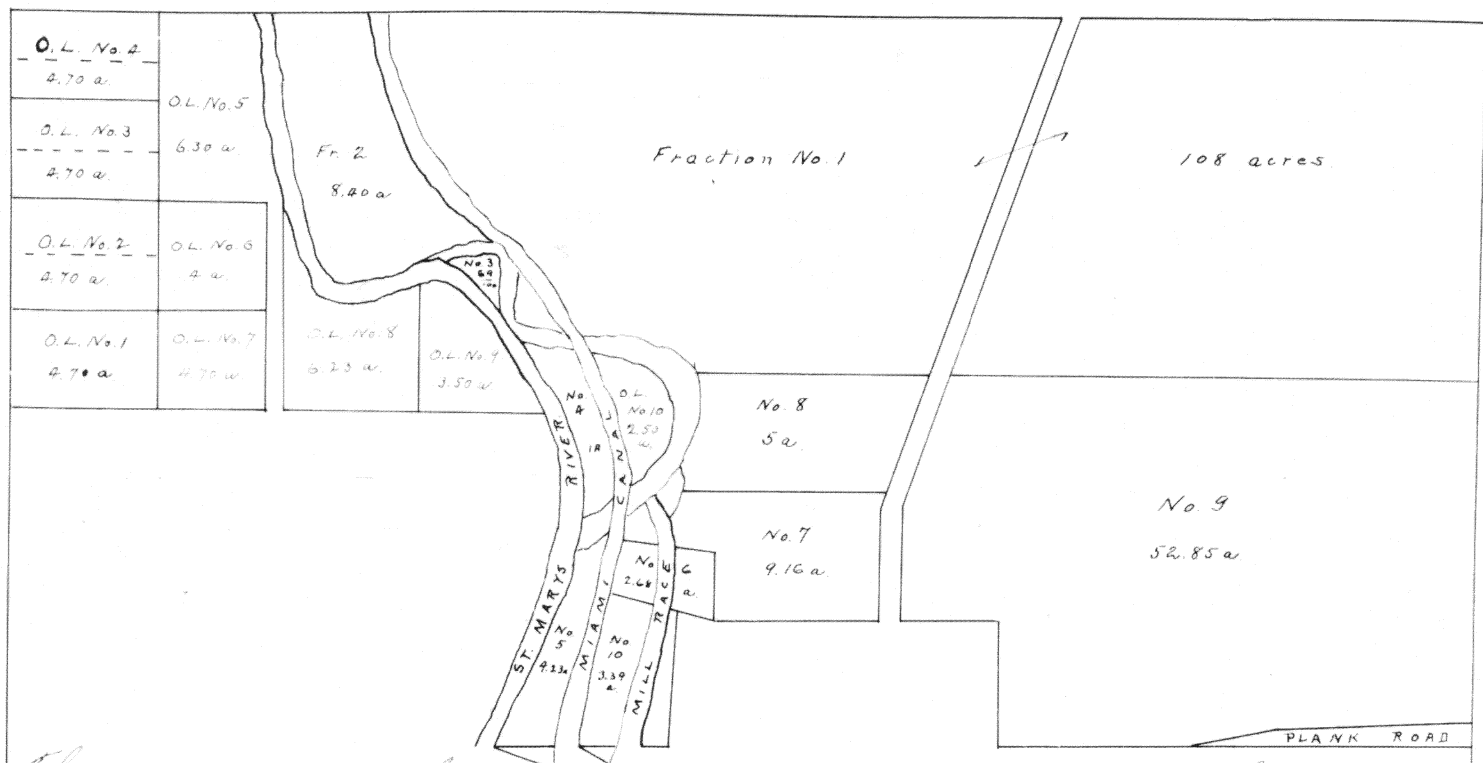




This map represents all the Out Lots and Fractions of Sect. No. 3 and No. 10 that is attached to the incorporated village of St. Marys by the Honorable Mayor and Council of said village at their regular meeting on May 17, 1870. The Out Lots are numbered with red ink and the Fractions are numbered with black ink. Done this 23^d day of May 1870.

Notes:

That portion lying south of the red line (indicated by the stars) is not included in the territory ceded. A copy of this has been entered upon the record, also a copy was sent to the Secretary of State for record. John M. Levin (seal)

Proceedings to an-
nex territory.

June 11th 1870

In the matter of the annexation of territory to the
corporation of St. Marys, Auglaize County, Ohio.

This day came the said Corporation by their
agent L. C. Sawyer, and presented a petition
accompanied by an ordinance passed by the council of said village; also
a plat of the territory proposed to be annexed, in words and figures fol-
lowing, to wit: To the Honorable Commissioners of Auglaize County,
Ohio: Your petitioners the Mayor and common council of the incorpo-
rated village of St. Marys, Ohio, respectfully represent that at a regular
meeting of said council, by a unanimous vote, they passed an ordi-
nance annexing the following described territory to said village, as part
of the corporation thereof, to wit: All of that part of Section three (3), Town-
ship six south of range four east in Auglaize County, Ohio, not already
included in the corporate limits of said village of St. Marys, Ohio, except
fraction number one of said section, consisting of Out Lots number 1, 2,
3, 4, 5, 6, 7, 8, 9 + 10 of McKee & Scotts Addition. Also fractions of said section
three being number 2, 3, 4, 5, 6, 7, 8, 9, 10, 21, 22, 26, 27, east part 27 west part 27
and 28 and all of the north half of Section ten in same town and range not
already included in said corporation, lying north of the Greenville road
and the lane running east from the intersection of the Original Greenville
roads to the St. Marys river, thence meandering with said river to
the section line on the east side of said section, consisting of Out Lots
number 1, 2, 3, 4, 5, 6, 7, 8, 11, 12, 13 of Mitchels West Addition. Also Out Lots
number 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 + 14 of Mitchels East Addition. Also
fractions of said section ten aforesaid number 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11
and that part of number 14 north of the lane. A complete map of
said territory is herewith filed marked A. A copy of said Ordinance
is hereto attached marked B. Your petitioners therefore pray that
such proceedings may be had by your Honorable body as may be
necessary to perfect the annexation of said territory to said village.

"B." - An Ordinance No. - to amend section two of an Ordinance
No. - entitled an ordinance relating to the enlargement of the cor-
porate limits, passed May 17th 1870. Be it ordained by the coun-
cil of the incorporated village of St. Marys, Ohio, that section two of the
above entitled ordinance be so amended as to read as follows:

Section I- Be it ordained by the council of the incorporated village of
St. Marys, Ohio, that contiguous territory hereinafter named, known
and described and designated as Out Lots and subdivisions of Out
Lots, fractions and tracts of land to the incorporated village of St. Marys
Ohio, shall be annexed for general corporation purposes and be sub-
ject to all existing ordinances, now or which may hereafter be in
force, to wit: Sec. II- All of that part of Section three (3) Township six (6) south
of Range four (4) east, in Auglaize County, Ohio, not already included in the
corporate limits of said village of St. Marys, Ohio, except number one (1) con-
sisting of Out Lots number 1, 2, 3, 4, 5, 6, 7, 8, 9 + 10 of McKee and Scotts Addition,
Also fractions of said section three, being numbered 2, 3, 4, 5, 6, 7, 8, 9, 10, 21,
22, 26, 27, East part 27 and west part 27 and 28 and all of the north half
of section ten (10) in said town and range, not already included in

said corporation lying north of the Greenville road and the lane running east from the intersection of the Piqua and Greenville roads to the Point Marys river, thence meandering with said river to the section line on the east side of said section, consisting of Out Lots numbers 1, 2, 3, 4, 5, 6, 7, 8, 11, 12 + 13 of Mitchels West Addition, Also numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 + 14 of Mitchels East Addition, Also fractions of said Section number ten (10) aforesaid numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and the part of number fourteen (14) north of the lane. Sec. III Be it further ordained that L. C. Sawyer is hereby appointed and authorized to prosecute all proceedings necessary to effect the annexation of the aforesaid territory for the use and purpose therein mentioned. Sec. IV That Section 2. of the Ordinance to which this is amendatory be and the same is hereby repealed. Passed June 4th 1870.

It is ordered by said Commissioners that the same be filed and set for hearing on the 8th day of August 1870 at 2 o'clock P.M. and it is further ordered that said corporation, by their said Agent, proceed forthwith to give notice of the time and place of said hearing in the Anglairs County Democrat, and by posting up a notice of the same as required by law.

Sawyer being first duly sworn says, he caused a true copy of the following notice to be posted up in one of the most public places, to wit: the Town Hall in said town of St. Marys for more than 60 days prior to the 8th day of August AD 1870, and that he also caused to be published a true copy of said notice in the "Anglairs County Democrat" a newspaper of general circulation in said town and county of Anglairs for more than 60 days prior to the 8th day of August AD 1870.

In the matter of annexing territory to the Town of St. Marys.

This matter coming on to be heard L. C. Sawyer, counsel for corporation, produced a notice with proof of service of the same as required by law in words and figures as follows:

To all whom it may concern: You are hereby notified that on the 6th day of June AD 1870, the corporation of St. Marys through their Common Council, in pursuance of an ordinance passed by said Council at a regular session thereof, filed their petition in the Auditors Office in said county, asking the Commissioners thereof to annex the territory hereinafter described to said corporation, and to make said territory a part thereof, to wit: All that part of Section three (3), town six (6) north, of range four (4) east in Anglairs County, Ohio, not already included in the corporate limits of said village of St. Marys, Ohio (except fraction number one (1) consisting of Out Lots number 1, 2, 3, 4, 5, 6, 7, 8, 9 + 10 of McKee and Scotts Addition, Also fractions of said Section three (3) being numbered 2, 3, 4, 5, 6, 7, 8, 9, 10, 21, 22, 26, 27 east part 27 west part and 28, Also all of the north half of Section ten (10) in said town and range, not already included

in said corporation lying north of the Greenville road and the lane running east to the St. Marys river, thence meandering with said river to the Section line on the east side of said section consisting of Out Lots number 1, 2, 3, 4, 5, 6, 7, 8, 11, 12 and 13 of Mitchels West Addition. Also number 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 and 14 of Mitchels East Addition. Also fractions of said Sect. number ten (10) aforesaid numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and the part of number fourteen (14) north of the lane: that the same is set for hearing on the 8th day of August AD 1870 at 2 o'clock P.M.

This cause coming on further to be heard upon the petition and accompanying papers and the Commissioners of said county of Auglaize finding that the same contains all the matters required and that its statements are true, and that the map or plat as filed in this case is accurately made. It is therefore ordered by said Commissioners that said proposed territory as set forth in said petition and described in said map or plat be and the same is hereby annexed to be made a part of the incorporated village of St. Marys, Ohio. It is further ordered that the Auditor proceed and make the records and transcript in this case as required by law.
