Incorporation of Buckland.

In the matter of the incorporation of Whitefeather as the village of Buckland for all purposes } Petition for incorporation of the town of Whitefeather under and by the name of Buckland, Ohio.

To the Hon. the Board of County Commissioners of Auglaize County, O. Gentlemen: We the undersigned resident inhabitants, citizens and electors of the town now known as Whitefeather and residing on the territory hereinafter described, would respectfully represent to your Hon. Body that we desire and request that the following described territory, a large portion of which has been laid out in lots a plat of which has been made and duly acknowledged and recorded, to wit: The East half of the North East quarter of Section No. 10; the west fractional half of the North West quarter of Sec. No. eleven (11) in town No. five (5) south of range No. 5 east in Auglaize County, Ohio, be changed from the name of Whitefeather to that of Buckland and organized into an incorporated village by the name of Buckland, there being no other incorporated village by the name of Buckland in the State of Ohio. Your petitioners further represent that the supposed number of resident inhabitants and citizens residing on said territory is about three hundred (300). We, the undersigned therefore desire and request that Fred Ziegenbush, Charles Ziegenbush and Dr. R. W. Sharp shall act as agents in our behalf in the premises. This cause came on for hearing upon the petition and exhibits, and Fred Ziegenbush one of the agents for said proposed corporation being present and represented by Van Anda & Walter, counsel for the agents of said proposed corporation. The Board of Commissioners after hearing the evidence and arguments of counsel and being fully advised in the premises, do find as follows: That the petition contains all the requirements as is provided by law, and the statements therein made are true and correct; And further that the name proposed for said corporation and village is appropriate; that the limits of said proposed

corporation are accurately described and are not unreasonably large or small: that the map or plat thereto attached is accurate: that the persons whose names are attached and subscribed to said petition are electors residing on the territory sought to be incorporated and that more than thirty electors residing on said territory have signed said petition on file in this case: that due and legal notice of the pending object and hearing of said petition has been given as is required by law: that there is the requisite population residing on the territory and within the limits of said proposed corporation. It is therefore ordered by the Board of Commissioners aforesaid that the prayer of the petition be granted and that said corporation be organized as prayed for and as is provided by law, and the name thereof be changed from Whitefeather to that of the incorporated village of Buckland Co.

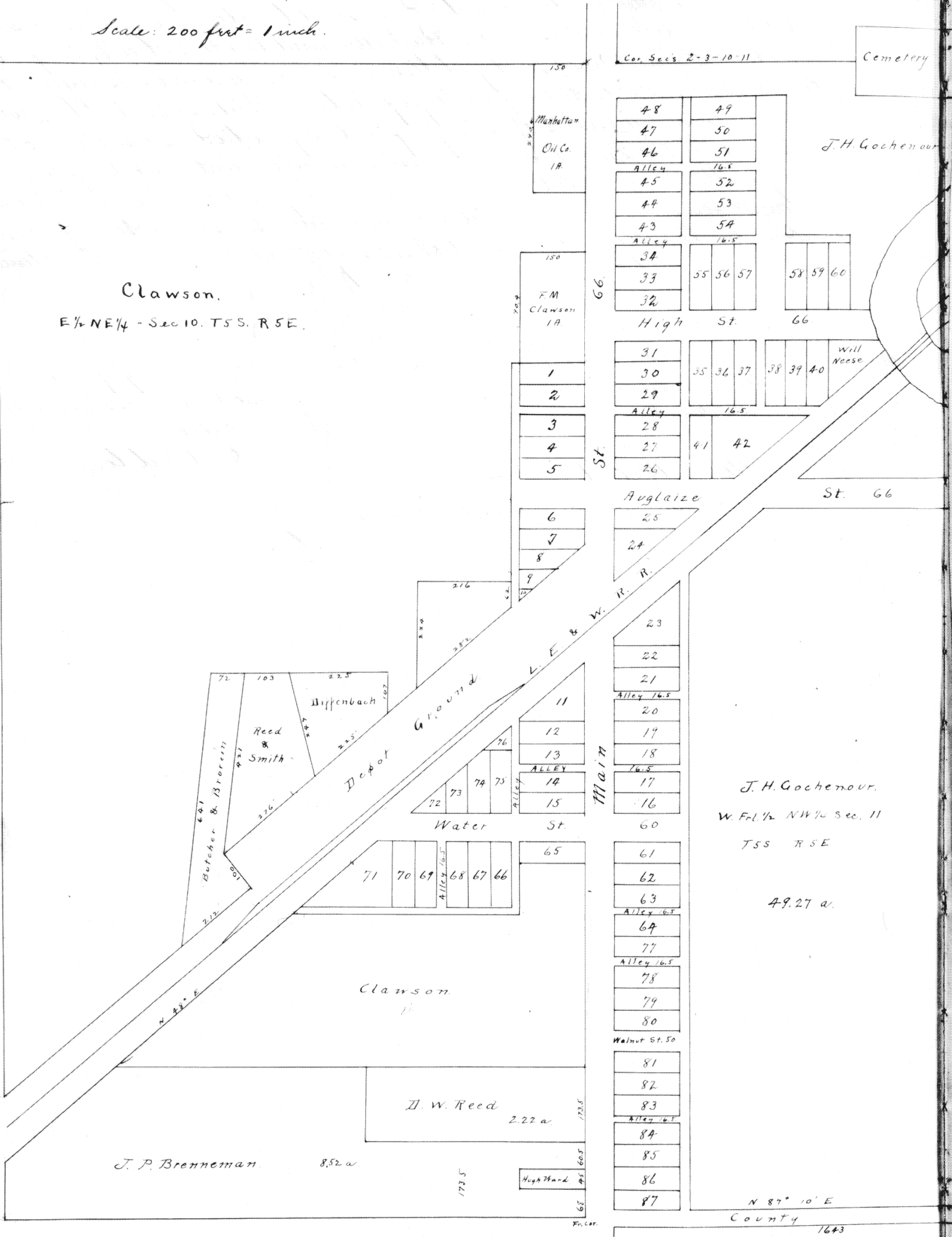
