Approving the plat of L. G. Neely & Carry M. Neely's Subdivision of Part of Out Lot Number Fifty three (53) and Lots number Forty one (41) and Forty two (42) of the West Addition to the Village of St. Marys, Auglaize Co. O., Sec. 1) Be it ordained by the Council of the Village of St. Marys, Auglaize Co. Ohio, that L. G. Neely and Carry M. Neely, Subdivision of Part of Out Lot number (53) and Lots number (41) and (42) of the West Addition to the Village of St. Marys, Ohio, shall be known as Lots One (1) and Two (2) of L. G. Neely and Carry M. Neely Subdivision of the Village of St. Marys, Auglaize Co. Ohio, be and the same is hereby accepted and approved, and the streets and alleys therein laid out and platted and dedicated to public use by the proprietors of said subdivision and are hereby accepted and such dedication confirmed and the same are declared to be public highways of said Village of St. Marys, Auglaize Co. O., and after a copy of said plat is filed in the office of the Clerk the City Clerk is hereby directed to approve said plat for record. Sec.
