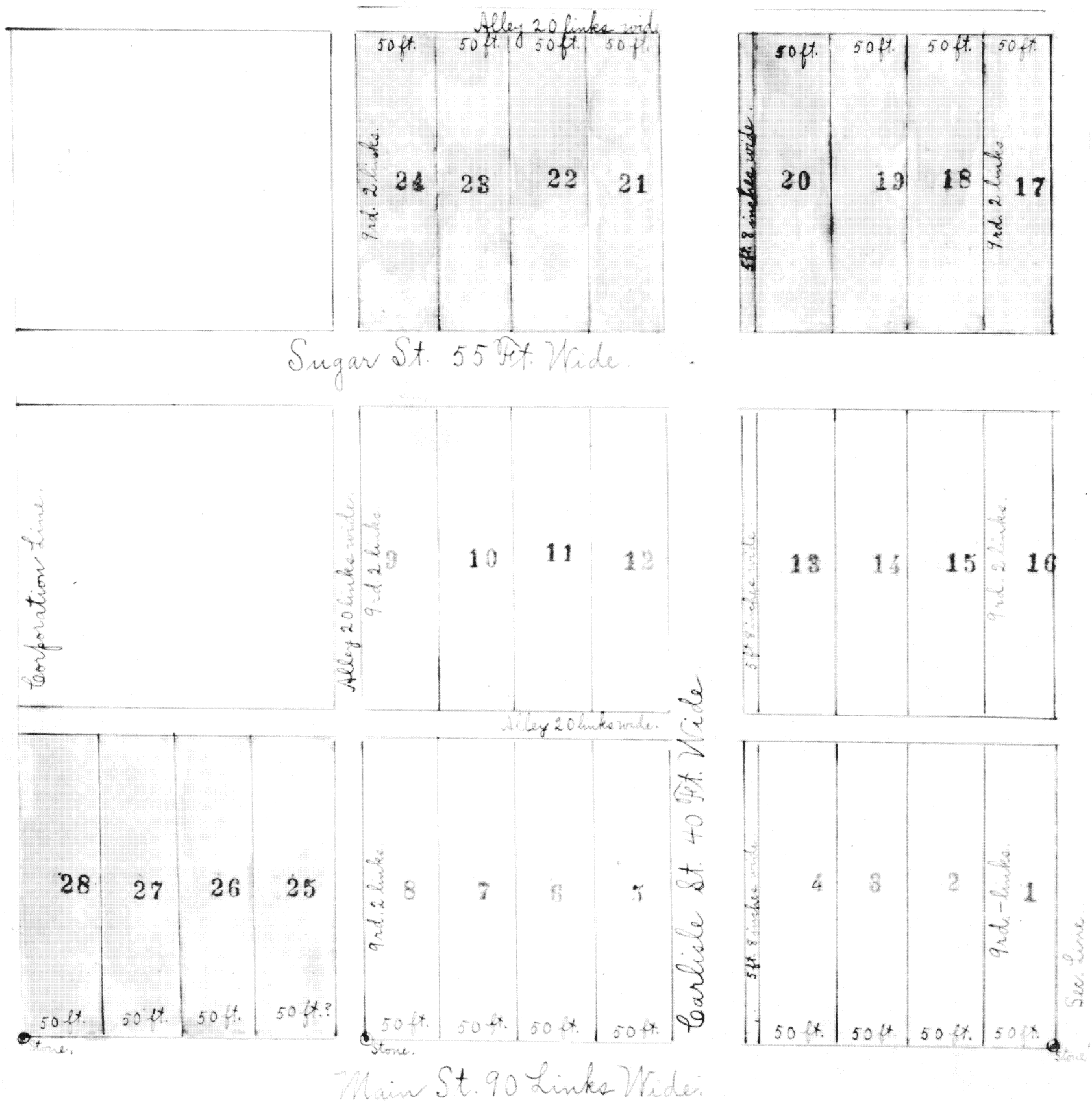


Cridersville.
Ezra De Long's West Addition.



The above colored portions of the foregoing plat represent Ezra De Long's addition of lots numbered 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, to his West Addition to the village of Cridersville, Auglaize County, Ohio. The aforesaid lots have been surveyed as an addition to a former addition known as Ezra De Long's West Addition to the village of Cridersville, Auglaize County, Ohio, and are deeded to the said village of Cridersville by Ezra De Long on the 7th day of July 1890. Width of streets and alleys are shown, also size of each lot.

No. 5138. — Know all men by these presents, That we Lydia De Long ^{2d} Ezra De Long, of Auglaize County, Ohio, do make public, adopt the annexed plat of division made by C. W. Williamson, a Surveyor, as their 2nd West Addition to a former west addition as herein shown uncolored ^{2d} recorded Sept 15, 1896, in Plat Book, No. 1, Page 343, conveying by this grant lots numbered 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, shown by colored parts of the plat, in the same section as shown on former plat in the town of Cridersville, Auglaize County, Ohio, of which we are proprietors, ^{2d} dedicate to the use of the public forever as highway the streets ^{2d} alleys therein, indicated ^{2d} named.
