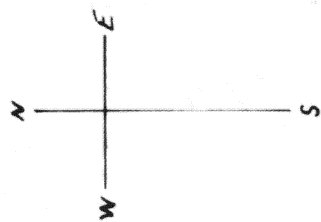

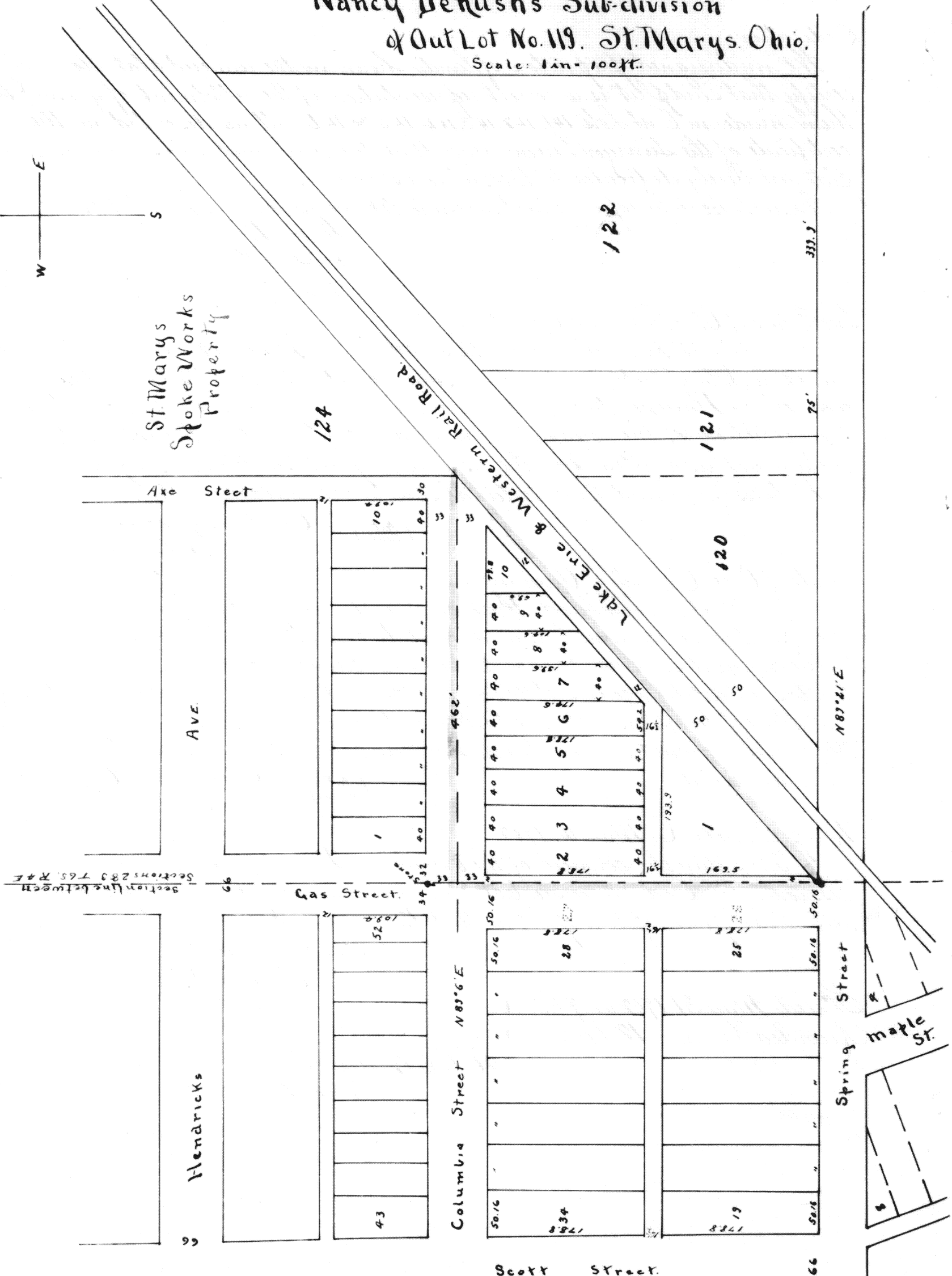

Ordinance # 270.

Approving the plat of Nancy DeRush's subdivision of Out Lot number One Hundred and nineteen (119) of the Village of St. Marys, O.

Be it ordained by the village council of the village of St. Marys, Ohio, as follows:

Section 1:- That Nancy DeRush's sub-division of Out Lot number one hundred and nineteen (119) of the village of St. Marys, Ohio, be accepted and approved, and the streets and alleys therein laid out and platted and dedicated to the public use by the proprietor of said subdivision, are hereby accepted and such dedication confirmed and the same are declared to be public highways of said village of St. Marys, Ohio, and after a copy of said plat is filed in the office of the village Clerk, the Clerk is hereby directed to approve said plat for record.

Section 2.- This ordinance shall take effect and be in force from and after its passage and publication according to law.

Done at the Council Chamber this 20th day of June, 1902.
