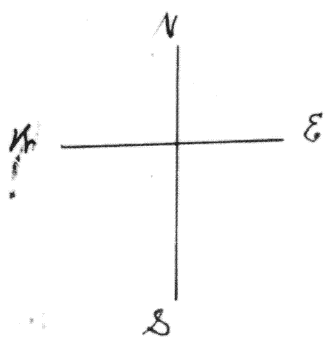


Resolution # 46 A-

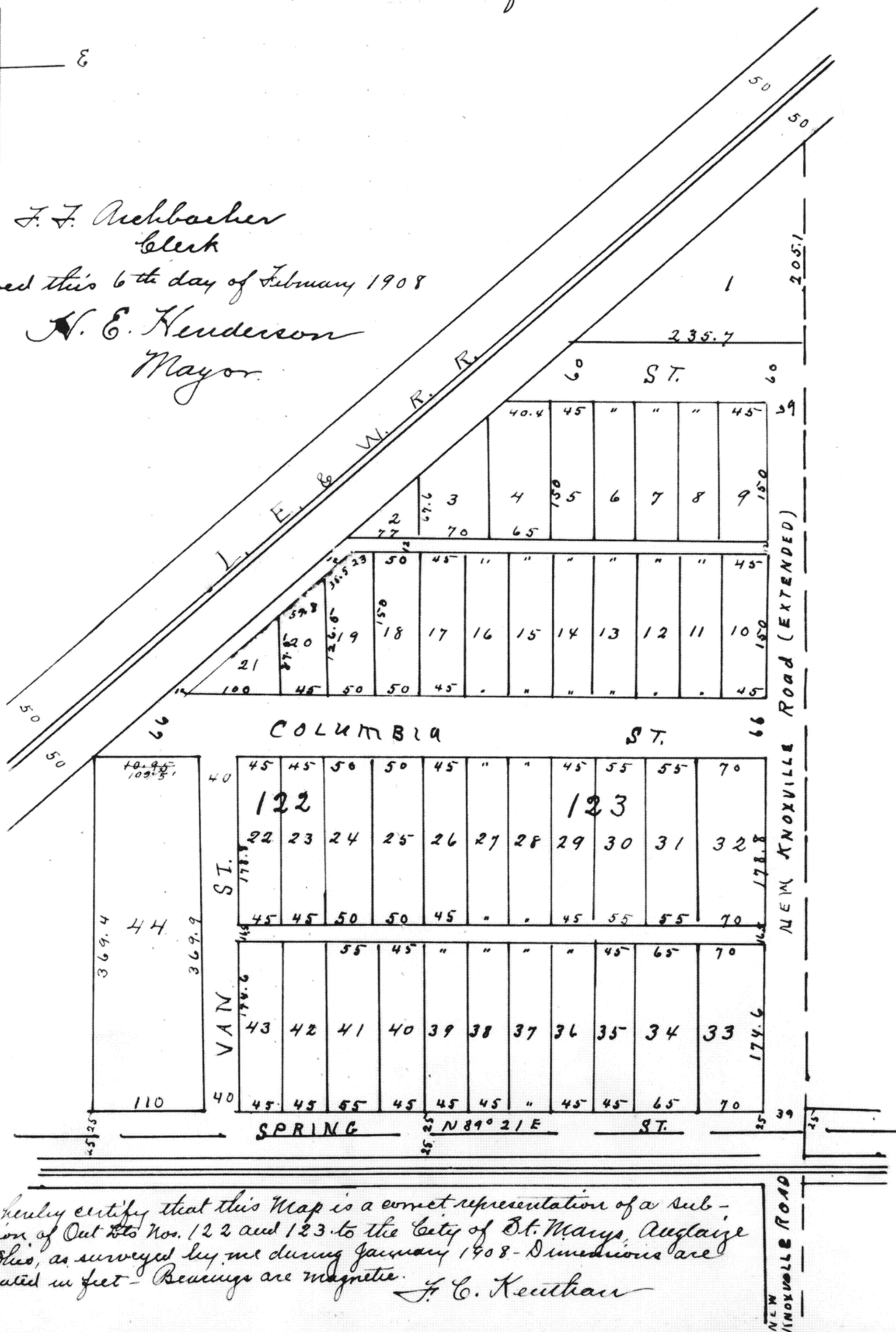

Veenfliet and wife, Annie O'Connell and husband, Henry D. Koepke and wife and John H. Koenig and wife; and the grantee, the several parties whose names are signed hereto: And Whereas the said several owners of said Out Lots numbers 122 and 123 having joined herein for convenience in platting said Out Lots, do hereby each certify, promise and agree that the undersigned own the several lots, parcels and fractions of said Out Lots 122 and 123 as his individual and separate property, and as shown on the accompanying Plat as follows: that is to say E.M. Veenfliet Nos. 1, 2, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 34, 38, 42, 43 and 44. Marion R. Adams No. 33. Louis Boltz No. 35. Ed Gordon Nos. 36 and 37. Martin Engel Jr. No. 39. J. P. Shanks No. 40 and Harry W. Clausung No. 41 and we do hereby set apart, dedicate and convey the Streets and Alleys as indicated on the accompanying plat, to the public use of the inhabitants of St. Marys Ohio, and to the general public forever, and we do hereby acknowledge the accompanying Plat to be a true and correct plat of a Subdivision of Out Lots 122 and 123 to the City of St. Marys, Ohio. 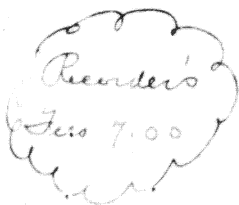
